

NCOM CONVENTION IN ORLANDO STRESSES UNITY

The underlying theme of the 34th annual NCOM Convention in Orlando, Florida, May 10-12, was "Unity" and welcomed back many past supporters and saw lots of new faces in the crowded conference rooms of the Doubletree by Hilton - Universal host hotel.

During the General Session, Outsiders MC member David "Double D" Devereaux, founder of the Motorcycle Profiling Project and member of the NCOM Legislative Task Force, spoke convincingly of the need for Unity in attaining our common goals, particularly in regards to state and federal anti-profiling legislation, and NCOM Chairman James "Doc" Reichenbach echoed those sentiments to the assembled representatives of hundreds of clubs, organizations and NCOM Member Groups.

One of the largest NCOM Conventions to date, this year's gathering drew biker activists from motorcycle rights organizations (MROs) and Confederations of Clubs (COCs), as well as independents and other allied riders from across the country. Motorcycle Profiling and "Save the Patch" were hot topics considering the recently victorious Mongols MC court case as well as the eventual dismissal of charges in the Waco catastrophe, while other important issues of concern to our nation's motorcycle community included various legal and legislative seminars regarding RICO And Its Effect on Your Organization, Restoring Your Rights, Leadership 101 and "Share the Road" Motorcycle Safety.

Capping off a productive Convention weekend, the Silver Spoke Awards Banquet recognized outstanding freedom fighters; Congressman Tim Walberg of Michigan (GOVERNMENT), James "Hollywood" Macecari of Insane Throttle Motorcycle Magazine (ENTERTAIN-MENT), Jim Wear, founder of the Salute to American Veterans Rally (COM-MERCE), with SPECIAL RECOGNI-TION AWARDS presented to David Duff of ABATE of Iowa, William Bird of ABATE of Florida and Mike Friend of Bikers For Christ. NCOM's highest honor, the Ron Roloff Lifetime Achievement Award was bestowed upon "JR" Reed -1%er of Sons of Silence MC and Smitty 1% er of the Outlaws MC.

Coast to Coast

All motorcyclists are encouraged to contact their Congressional Representatives to ask for their support of House Resolution 255, a bipartisan anti-profiling measure introduced in the U.S. House of Representatives that is identical to Senate Resolution 154 passed by unanimous consent in the U.S. Senate late last year.

H.Res.255; "Promoting awareness of motorcycle profiling and encouraging collaboration and communication with the motorcycle community and law enforcement officials to prevent instances of profiling," was introduced March 26 by Rep. Tim Walberg (R-MI) and currently has 22 co-sponsors.

Both nonbinding resolutions, S.Res.154 & H.Res.255, call for cessation of law enforcement discriminatorily profiling motorcyclists by thwarting "the illegal use of the fact that a person rides a motorcycle or wears motorcycle related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United States," as profiling is defined by each resolution.

Concerned riders can contact their U.S. Rep. by calling the Capital Switchboard at (202) 224-3121 and request that they join their colleagues in cosponsoring H.Res.255 to put an end to law enforcement unfairly targeting motorcycle riders for traffic stops, questioning and citations.

MOTORCYCLE SAFETY AWARE-NESS MONTH CONGRESSIONAL RESOLUTION

On May 1, 2019 U.S. Rep. Michael Burgess (R-TX) submitted House Resolution 338 in the U.S. House of Representatives; "Expressing support for the designation of May 2019 as Motorcycle Safety Awareness Month," which reads:

"Whereas motorcycling is a great American tradition enjoyed by an estimated 27 million people annually, representing almost 9 percent of the population;

Whereas motorcycles are a valuable component of the transportation mix;

Whereas motorcycles are fuel-efficient and decrease congestion while having little impact on our Nation's transportation infrastructure;

Whereas the motorcycling community promotes rider education, licensing, and motorcycle awareness;

the passage of the Natural Resources Management Act, S.47, now Public Law No: 116-9 after being signed March 12, 2019 by President Donald Trump, affirming the existence and proper management of millions of acres of public lands and parks, including Off-Highway Vehicle (OHV) areas, for years to come.

The law permanently reauthorizes the Land and Water Conservation Fund (LWCF) and the Every Kid Outdoors Act for seven years. Collectively this legislation will benefit thousands of parks, public lands, and waters as well as providing access to the outdoors to millions of off road motorcycle and ATV riders across the country.


The Land and Water Conservation Fund is America's most important conservation program, responsible for protecting parks, wildlife refuges, and recreation areas at the federal, state, and local levels. Many of the lands that NPT has transferred to the National Park Service were purchased with funding from LWCF, including Rocky Mountain National Park, Washita Battlefield National Historic Site, Glacier National Park, Appalachian National Scenic Trail, Kennesaw Mountain National Battlefield Park, and Zion National Park.

The sweeping Act reflects the bipartisan Senate-House agreement reached near the end of the last Congress to bundle together over 100 individual lands bills, striking a balance between creating new opportunities for natural resource and community development with limited, locally-supported conservation. It will improve public lands management, protect treasured landscapes, and increase public access for recreation while protecting private property rights.

Last year, the government released national data demonstrating the importance of an outdoor recreation economy that accounts for 2.2 percent of the nation's Gross Domestic Product and directly supports 4.5 million jobs.

MONGOLS FINED \$500,000 & GIVEN PROBATION, BUT RETAIN TRADE-MARKED LOGO

At a sentencing hearing on Friday, May 17 a federal judge in California fined the



Mongols Motorcycle Club \$500,000 and put the club on probation for five years following its racketeering and conspiracy convictions, but rebuffed yet another attempt by prosecutors to strip the group of its trademark protected back patch logos, citing constitutional protections against intrusions on free expression and excessive penalties.

Last December, a jury found the Mongol Nation as a whole guilty of RICO charges in a decade-long case in which prosecutors said the group operated an organized criminal enterprise. That jury further decided at the time that the government could seize the Mongols intellectual property, but in February U.S. District Court Judge David O. Carter intervened and refused to approve the asset forfeiture.

Stephen "Bowtie" Stubbs, lead attorney for the Mongols, called the judge's decision to not strip its identifying insignia a victory for all motorcycle clubs, but said that the \$500,000 would be a "major burden" to bear for current members who had nothing to do with any of the alleged behavior of past members, and told NBC News that the club plans to appeal the entire case.

"The Mongols Motorcycle Club is very pleased that Judge Carter shut down another attempt by the government to limit symbolic speech," said Stubbs, of Las Vegas, who is a member of the National Coalition of Motorcyclists Legislative Task Force (NCOM-LTF) and also serves as legal counsel for the Southern Nevada Confederation of Clubs (COC).

Prior to the sentencing hearing, prosecutors tried again, requesting the Mongols be prohibited from preventing others from using their image, which Stubbs said the judge also denied.

SHOW-ME FREEDOM OF CHOICE

Missouri is the latest state looking to give motorcyclists the freedom to choose whether or not to wear a helmet while riding, and hopes to soon become the 32nd state behind Michigan in 2012 to allow adult Freedom of Choice. The legislative package, including other transportation provisions, passed the Senate 21-12 on Thursday, May 16 and on Friday the House advanced Senate Bill 147 to Governor Mike Parsons (R) on a 94-46 vote.

If signed into law, SB 147 would repeal their decades-old helmet law and allow motorcyclists 18 and older the option to ride without a helmet, provided they carry proper health insurance. Like Michigan, which shook off the sting of two previous gubernatorial vetoes of their helmet law repeal bills before bouncing back to amend their mandatory helmet law, Missouri's legislature previously passed a helmet law repeal in 2009 which was vetoed by then-Governor Jay Nixon (D), and in 1999 a helmet repeal bill reached the desk of former Gov. Mel Carnahan (D) who vetoed it -- members of Freedom of the Road Riders (FORR-MO) and ABATE for Missouri are hoping this time's the charm!

"SB 147 has passed through both chambers, and only needs a signature from the governor (who can be reached at (573) 751-3222)," reports www.forr.net. "Yes, everybody Happy Happy," commented Tony Shepherd of ABATE, a past member of the National Coalition of Motorcyclists (NCOM) board of directors, who has worked diligently towards passage with FORR-MO Legislative Coordinator Joe Widmer.

CONNECTICUT MAY EXTEND HEL-MET LAW FROM 18 TO 21 AND UNDER

Helmet laws vary from one state to the other, with some rules being more flexible than others, and at least until now motorcycle helmets were not mandatory in Connecticut for riders aged 18 and over. Prior to January 1, 1990, Connecticut was one of just four states that had no helmet requirement, but if passed House Bill 6161 would increase the minimum age for compulsory helmet use from Under 18 to Under 21.

HB 6161 passed the House by a vote of 113-13 on May 14th and is now heading to the Senate for consideration and vote.

Language instituting a universal helmet law for all riders was stripped from a larger bill, and although they still express opposition to any further attempt to mandate helmet use by adults, the Connecticut Motorcycle Riders Association (CMRA) has already claimed a victory in defeating that measure; but advocates hoping to finally reinstate Connecticut's full motorcycle helmet law after 43 years still hope they can pass legislation next session, despite their setback.

(4) recognizes that motorcyclists have a right to the road and that all motorists should safely share the roadways;

(5) encourages rider education and training for safe motorcycle operation; and

(6) supports the goals of Motorcycle Safety Awareness Month."

H.Res. 338 has been referred to the Subcommittee on Highways and Transit of the Transportation and Infrastructure Committee, and currently has 7 cosponsors.

In addition to being a brilliant political strategist, Saul Alinsky was a keen observer of human nature.

Human beings can sustain an interest in a particular subject only over a limited period of time. The concentration, the emotional fervor, even the physical energy, a particular experience that is exciting, challenging, and inviting, can last just so long —this is true of the gamut of human behavior... After a period of time it becomes monotonous, repetitive, an emotional treadmill, and worse than anything else a bore.

Alinsky warns readers that the worst opponent activists battle isn't the other side. "From the moment the tactician engages in conflict, his enemy is time."

Of course, Alinsky doesn't blame people for losing interest in a cause as time goes on. "New issues and crises are always developing, and one's reaction becomes, "Well, my heart bleeds for those people and I'm all for the boycott, but after all there are other important things in life' and there it goes." couraging enough to make you want to quit.

Remember that the definition of insanity is doing the same thing over and over again, expecting different results.

When you're developing your strategy, look for ways to be creative and innovative.

Try new tactics and test whether they're effective. Ask your activists to give you their ideas. Don't let your tactics become a drag.

And above all, avoid being a bore.










































SUPERSTION CHAPTER HITS THE ROAD IN 5TH GEAR!

Insurance Companies Make \$1000 For Each Speed Camera Ticket

California red light camera tickets boosted insurance industry profit by \$1.5 billion over five years.

Neither the cities that have traffic cameras nor the private companies that operate them are the biggest financial beneficiaries of photo enforcement. In states like Arizona and California where automated citations carry points against the recipient's driver's license, insurance companies are generating four times more revenue from photo tickets than California and Arizona cities.

The Zebra, an online car insurance cost comparison website, analyzed insurance rates for 61 million policies from 650 insurance companies nationwide over the last eight years. The company distilled its findings on 43,500

potential ratings factors into an annual report on the state of automobile insurance. The latest report calculates that insurance companies are pocketing \$1000 in additional profit for every photo citation issued in states where such tickets carry license points.

The Zebra found that different types of traffic violations carry varying levels of impact on the cost of insurance. For instance, insurance companies on average collect an extra 6.7 percent, or \$293, from drivers who are involved in an accident caused by another motorist. An at-fault accident costs \$1851 -- a 42 percent premium hike. Being issued a ticket for using a cell phone behind the wheel can cost \$864, and a drunk driving conviction will boost rates \$3,258 over three years -- an increase of 74 percent.

Receiving a red light camera ticket in states like California and Arizona raises an individual's insurance premium by

\$999 over three years. A speed camera ticket in Arizona, likewise, carries an extra cost of \$1024. This is only part of the total cost for California drivers, who are also on the hook for each \$490 ticket. While California has the nation's highest photo ticket cost, the cities do not pocket anywhere near \$490 per ticket, as profits are split with the county government and the for-profit camera vendor. The insurance companies face no such costs, and the companies do not provide any additional services for the added premium.

The amount of revenue being generated is substantial. Last year, Scottsdale, Arizona's speed camera vendor issued 41,961 tickets worth \$43 million in profit to the insurance industry. Using figures from the California Judicial Council obtained by HighwayRobbery.net, 1,510,705 red light camera tickets were issued statewide between 2013 and 2017. That

represents \$1.5 billion in added profit to AAA, State Farm, Geico, Allstate, Progressive and other insurance firms over five years. That is a far more significant take than the \$740,245,450 split between the camera companies and local governments over the same period.

The insurance industry has spent millions promoting the use of red light cameras and speed cameras nationwide. The first and most vocal advocate of automated ticketing has been the insurance industry's lobbying arm, the Insurance Institute for Highway Safety (IIHS), which created the very first studies used as a justification for the installation of cameras.

Check your tires. Don't drink and ride! And if you do not have a motorcycle endorsement on your license, take a class and get one. AMSAF offers scholarships and there are other ways to get classes, even for free! If you don't know how, Google it, or ask your chapter Safety Officer. But whatever you do, please ride safely. Going to a biker funeral is not my idea of a fun ride.

Meanwhile, Have Fun, Ride Free, Ride Safe, Ride Endorsed and watch those intersections!

What you need to know about the New Arizona Texting Law

What will be forbidden?

The new law will make it illegal to "physically hold" or "support with any part of the body" any cell phone or other portable wireless communication device while operating a motor vehicle. There was some debate - and no clear answer - on what constitutes "support" of a phone, and whether that means in the lap, in the pocket or elsewhere. But from a

practical standpoint, if it's in a lap, it is unlikely that a police officer would see it and pull someone over. The law bans not only chatting on the phone but writing, sending and reading text messages, emails, instant messages or internet data.

What are the key exceptions?

Drivers can make calls if they use earpieces, headphones or any type of device worn on a wrist to conduct voice communications. Vehicles with built-in interfaces



with cell phones also are exempt as long as they can be operated with minimal interactions, meaning simply to press a button to activate or deactivate. People also can "read" texts if these are translated into voice. And they also can send texts if done through voice commands. A phone's map and GPS are permitted if in a hands-free mode.

What about other types of devices?

The same restrictions on holding a cell

video screens that provide information about the vehicle. The legislation also adds a provision designed to protect people who have dash cams and similar devices that continuously record what's going on, either in the vehicle or on the road.

Are there other types of operations that are not subject to the law?

Motorists can use a cell phone to "report illegal activity or summon emergency help." Also not subject to new restrictions are licensed amateur radio operators and fleet drivers with commercial licenses communicating with a dispatcher. And for those who are still attached to their citizen band radios, you can keep yakking away, good buddy.

What about when I'm stopped?

It depends on where. Motorists who are parked are exempt and can call and text at will. Ditto if you're at a stop light or waiting for a train to clear a railroad crossing. But a stop sign does't count. Nor does being stopped for a school bus. phone also apply to any "stand-alone electronic device." That means anything with stored audio or video – so, no hanging on to the phone while listening to previously recorded podcasts or watching tapes of Game of Thrones.

What about watching live TV?

That already is illegal. But the new law clarifies that the statute does not apply to mapping services, which update images, as well as to cars and trucks with built-in

No. There is an exception for "when authorized by law," but there is no definition.

When does all this take effect?

January 1, 2021. That does not't preclude an offending motorist from being stopped between now and then, though police could issue only warnings for violating the new law.

But what about all those existing local laws?

Those remain in effect and can still be enforced, including provisions that are stricter than what's in this new law. So, if a local ordinance has no exception for stop lights, motorists can still be cited. But as of Jan. 1, 2021, any provision that does not mirror the state law will disappear.

If there's a delayed effective date, why the emergency clause?

What are the fines?

A first offense carries a minimum fine of \$75 and up to \$149. Subsequent violations result in fines of at least \$150 and no more than \$250. But the offenses accumulate no points on a motorist's license. There is an exception: Licenses can be suspended if someone is violating the new law and causes a serious injury or death.

Do I have to give my cell phone to a police officer when stopped?

One provision that takes effect immediately requires the Motor Vehicle Division to now start testing would-be drivers on the effects of using cell phones and similar devices. Another new section allows MVD to suspend the commercial driver's license of someone who violates the law.

EL PASO, Texas – El Paso Police made 35 arrests and issued 118 citations during a Cinco de Mayo crackdown on motorcycle gangs.

Police released the figures Tuesday in response to an ABC-7 request for

information. Several ABC-7 staffers and viewers noticed police pulling over groups of motorcyclists during the entire Cinco de Mayo holiday weekend.

The three day operation from May 2nd to May 5th was "conducted in response to the large number of out-

law motorcycle gang members anticipated to be visiting the city that weekend," police said.

Police did not specify the extent of the charges filed, nor did they identify those arrested.

The El Paso Police Department's

Gang, TAC and SWAT units participated in the operation along with partner, local, state and federal agencies from the Texas Anti-Gang Center. –KVIA, ABC News

Biker Civil Rights Memorial Announced

Four years ago on May 17, 2015 nine bikers were killed, 17 Wounded & 177 arrested without due process, at Waco Texas . This Biker Tragedy is the most horrendous violation of Biker civil Rights in world history !

Five of the nine bikers were killed by 223 caliber bullets fired from an elevated position-most certainly by police snipers. Many Bikers could not afford the \$1 million bond and eventually lost jobs, homes & families.

All state and federal charges against the bikers were dropped on April 2, 2019. But the mystery is even more alarming, since it is not known who started the conflict. There is uncertainty of whom shot who or even who really escalated the conflict.

At Waco in 1916, a developmentally disabled black boy —Jesse Washington was found guilty of allegedly raping a white woman. He was castrated in the courtyard.

Then hung over a fire for 4 1/2 hours & lynched to death. His genitals, fingers and toes were sold & given away as souvenirs.

On Saturday, September 14 at Camp Bubba's Resort & Event Center, near Tomahawk, Wisconsin, a double sided 4 x 8-foot sign will dedicated in recognizing these three Waco tragedies. Tomahawk is the site of one of three Harley Davidson manufacturing facilities. The other plants are in Milwaukee Wisconsin and York Pennsylvania.

Special guest speakers will address Bikers about being stereotyped, discriminated against and profiled..Bikers See Heroes indeed!

So far confirmed are Frank Ernst, Chairman of the National Coalition of Motorcyclists . He serves as Chairman of the Legislative Task Force. Gerald Unger/ Illinois was A senior med-

ical examiner in New York City during the 2001 Twin Towers attack . He spent much time in DNA identification of victims .Gerald is a very prominent attorney with a stellar career. Many want him to

be drafted onto the Harley-Davidson Board of Directors, becoming the only real "Biker" on that board.

Others being consideredarw Gary Wetzel / Oak Creek Wis, a Vietnam Congressional medal of honor recipient . Also Tommy Tradewell – Veterans Of Foreign, who was the first national commander of any major veterans organization.

Vicki Sanfelipo, founder of Accident Scene Management, trains hundreds of bikers a year to save lives, is being eagerly sought.

Also to be then dedicated is the Miracle Mountain Motorcycle Monument. Other patriotic signs and exhibits include; RIZEN, The Highground Veterans Park ,Native American Indian culture, Crazy Horse, Bobville Talent Park & Big and Little Indian Farms, the Harley Fame of Shame & Wis Adventures on Wheels .

A special salute to Law enforcement, firefighters and EMTs is evolving —as with other exhibits to yet be announced.

Motorcyclists and those who share the road are reminded to practice safe driving as May marks Motorcycle Safety Month.

The City of Grande Prairie Enforcement Services stated it would focus on motorcycle safety for the Selected Traffic Enforcement Program (STEP).

"All motorists are reminded to be aware of their surroundings and exercise a higher degree of caution when more vulnerable vehicles such as motorcyclists are in the vicinity," the city said in a statement. "Motorcyclists in particular have a higher likelihood for injury in the case of an accident due to their exposed vehicle."

"Motorcyclists should drive cautiously and defensively, never assume other motorists are aware of your presence," the city added.

According to the city, motorists should:

Look twice for motorcyclists at intersections, when turning, and when changing lanes.

Never underestimate the speed of a motorcycle, their size makes their speed deceptive.

Ensure you allow extra space between your vehicle and motorcycles as they can stop faster than other vehicles around them.

"Safety is everyone's responsibility, whether you drive a car, truck or motorcycle," the city said. "Help protect the

reminded motorcyclists to adopt safe driving behaviours in order to reduce the risk of collisions.

"With season change and warming weather, motorcycles are prevalent on our roadways. In 2018, there were 12 people killed and 232 motorcycles involved in injury collisions in Alberta RCMP jurisdictions," said Supt. Gary Graham with Alberta RCMP Traffic Services in a statement. "These numbers are a good reason to raise awareness about safe motorcycling so that we all get to our destinations safely."

Alberta RCMP offered the following motorcycle safety tips:

Gear up! Along with a helmet, riders should wear shatter-proof eye protection and durable weather-proof clothes to keep you comfortable while riding.

Stay bright and in sight! Staying out of blind spots on roadways and in parking lots will help keep other vehicles aware of your presence.

Showing off does not pay off - but driving defensively does. Remember, motorcycles are smaller than most vehicles. Be aware of your surroundings, share the road and change lanes with extreme caution.

Practice makes perfect. Riders should practice on safe roads away from high traffic areas and highways to make sure they are comfortable and confident in their skills on the road.

Four years later: Twin Peaks survivor hopes to change biker profiling

A Twin Peaks shooting survivor says he trying to rebuild his reputation after he was one of the bikers arrested at the Waco restaurant in 2015.

Friday marks four years since the deadly shootout at the Waco Twin Peaks.

"This was a scheduled meeting," said Paul Landers.

Landers said he got to the restaurant early that day to set up for a meeting about biker profiling, recent biker legislation and their rights on the road. "That day was different because there were people there that never participated at all in what we do," he said. He said he was hanging a banner when he heard the first shots. "Some automatic fire broke out, obviously not small arms fire broke out," he said.

Nine people were killed and at least 20 were critically injured. If you were there as a biker, chances are you were arrested by Waco Police.

Landers was one of them. "That incident happened 12:30, one o'clock. We were on the hot concrete in 97-degree weather until five that evening. People (were) looking for a restroom. It was total chaos. You don't know what's going on, who's involved. Then we sat on the bus until midnight. I was in handcuff until midnight, plastic cuffs," he said. Landers said he spent the next 23 day in jail. He along with 177 others faced felony charges — engaging in organized criminal activity, resulting in murder and aggravated assault.

Charges for Landers were dropped three years after his arrest. In early April, the remaining charges were dropped after a new DA took office.

Landers said his life still hasn't been the same since his arrest. "I'm not a criminal," he said.

Before the shooting, Landers said he worked for a well-paying company but was terminated within a week after his arrest. He said the reputation he built as an advocate for biker safety with policy makers at the state Capitol started to diminish. "If you want to single out the bad deed of a couple, but don't indict the whole group on the actions of few," he said.

Landers is now part of a civil suit suing the former McLennan County District Attorney, Waco Police and the detective that signed off on the affidavit. He said he's not suing for financial gain but to prevent bikers from being profiled like he feels they were on May 17, 2015 in Waco.

"Never let this happen again," he said.

California regulator threatens ban on gasoline engines

WASHINGTON — California's top environmental regulator is threatening to enact tougher pollution rules that could include a ban on vehicles that burn petroloum based fuels in retaliction for the communities get the reductions of air pollution they so desperately need to keep the air clean and breathable — and continue to fight climate change," Nichols said in draft remarks prepared for an event Thursday. ing Obama-era rules, fuel economy requirements are set to rise to 47 mpg.

Uncertain future

The administration in February terminated months of talks between federal regulators and California officials to maintain a common standard. Automakers had urged the two sides to reach an agreement to avert a prolonged legal battle with California, which has unique authority to establish its own emissions rules. based fuels would be unprecedented in the U.S.

Britain, China, India and other nations have announced their own plans to phase out conventional vehicles with internal combustion angines

leum-based fuels in retaliation for the Trump administration's plan to relax vehicle emission standards.

The move — which would be a first in the U.S. — marks an escalation in the clash between Washington and Sacramento that would increase uncertainty for carmakers in the nation's biggest auto market.

California has already gone to court to fight the Trump administration's determination that current vehicle emission and fuel economy standards are too stringent. Now, California Air Resources Board Chairman Mary Nichols is arguing that the state will match any relaxation of federal auto rules with its own more stringent anti-pollution requirements on everything from fuel to the refineries producing it.

"CARB will be exploring ways to ensure

"That might mean, for example, tougher requirements for low-carbon fuels, looking at tighter health-protective regulations on California refineries, doubling down on our enforcement efforts on mobile and stationary sources — and might lead to an outright ban on internal combustion engines."

Nichols was set to deliver the remarks during a meeting with California air quality and transportation agencies. Representatives of the U.S. Environmental Protection Agency did not immediately respond to an emailed request seeking comment.

President Donald Trump's administration is developing a final plan for easing tailpipe carbon dioxide emissions standards and fuel economy requirements, after proposing to cap the mandates at 37 miles per gallon after 2020. Under existThe fight has already caused uncertainty for the auto industry, threatening to undermine business plans heavily reliant on predictability. A prolonged court battle over mileage mandates could upend technology development and investment plans for the U.S., even as European countries press on with tougher requirements.

But Nichols' comments show increasing peril for other industries too, particularly oil refineries. California already encourages zero-emission vehicles and legislation proposed in the state last year would mandate them by 2040. An outright ban on new vehicles powered by liquid, oilcombustion engines.

Tough limits

Even without that step in California, refiners could be hit with tougher limits on pollution at their facilities and more stringent fuel requirements.

Nichols casts the moves as a possible necessary step to offset additional air pollution that could be unleashed by Trump easing auto standards.

"The federal rule will pump hundreds of millions of tons of climate-changing gases into the atmosphere, and will increase the amount of smog-forming pollution in our most polluted cities," Nichols says in her prepared remarks. "Steps may be needed to keep moving forward to fight climate change and continue to protect public health if it ever goes into effect."
