



## **A United Front:**

While D.C. is a city full of divisions sometimes, it's nice to work together with like-minded groups for a common purpose. Last week, the MRF met with representatives from the American Motorcycle Association, Motorcycle Industry Council and Harley Davidson (AKA the Moto Lobby) to discuss common goals surrounding autonomous vehicles and safety concerns. The four groups have now agreed on a basic framework for our priorities and this week met with staff

of the House Energy and Commerce Committee to discuss the legislative agenda surrounding autonomous vehicles.

As you may remember last year, the Senate and the House had competing versions of legislation that dealt with autonomous vehicles. The Senate version did not receive a vote on the Senate floor while the House version passed the House



but was not taken into consideration by the Senate.

The Senate version included language that stated "detection, classification, and response to any circumstance or condition relevant to the dynamic driving task within the operational design domain, including sense of objects, motorcyclists, bicyclists, pedestrians, other road users, and animals in or crossing the path of travel through the automated driving system."

The House version of the bill took a different approach and did not mandate specific categories that AV technology had to recognize and react to. Our Moto Lobby pressed committee staff to consider adding language that would specifically list motorcycles as something that AV technology must test for.

The reality of Congress at this time

means any legislation dealing with AV technology is a steep hill to climb. With the Senate and House controlled by different political parties, any legislation that both chambers can agree on will be difficult. On top of that, the House committee assigned to the issue (Energy and Commerce) will be led by Democrats who will likely want to use committee time and resources to focus on issues like healthcare and climate change. While the Senate Committee with jurisdiction (Commerce Science and Transportation) has a new Chairman this year with new priorities which may not include tackling the AV issue.

Regardless, we at the MRF and the DC motorcycle community will continue to hammer away at legislators and agency officials warning them about our concerns and the need for a clear statement about AV technology and the safety of motorcy-

clists.

## NTSB RELEASED TOP TEN MOST WANTED LIST

Gone are the days when motorcycles were one of the issues on NTSB's Top 10 Most Wanted List. On Monday, The National Transportation Safety Board released it's 2019-20 Most Wanted List of Transportation Safety Improvements, and your MRF was pleased to see that we continue not to be a dedicated issue on this report. The comprehensive Top Ten list focuses on some things to note: distracted driving, impaired driving and most importantly, autonomous vehicle technology. As we have reported in the past, the DOT has been pretty laissezfaire on their guidance on the issue of autonomous vehicle regulation and legislation failed to move in the last Congress. In the section "Increase Implementation of Collision Avoidance Systems in all New Highway Vehicle," the NTSB made a recommendation that the National Highway Safety Administration (NHTSA) incorporate motorcycles in the development of performance standards for passenger vehicle crash warning and prevention systems. We are pleased to see for the first time that a government agency is seeing the importance of making sure motorcycles are properly detected and responded to by this emerging technology.

# Texas: Longer Yellow Time Experiment Is A Long-Term Success

A pilot project testing the effects of increasing the yellow warning time at intersections continues to demonstrate positive results in Denton, Texas. In April 2018, the city decided to appease red light camera critics by adding a second of yellow time to the photo enforced intersection of West Oak Street and North Carroll Boulevard. To the surprise of city staff, the 62 percent reduction in violations that began the day the timing was extended has lasted for ten months. Staff is now recommending a modest expansion of the test at the most profitable red light camera location.

"Using the number of violations as a

guide, staff is recommending to extend the pilot program (adding one second to the yellow signal interval) to the signals for both the northbound and southbound cameras at the intersection of I-35E and US 377 beginning March 1, 2019," a city staff report recommended on Friday.

Defenders of photo enforcement have claimed the benefits of extending yellow warning times dissipates over time. Denton's data show that the boost in yellow time from 3.5 seconds to 4.5 seconds has the same effect now as it did on the first day. There was a 64 percent drop in yellow in December 2018 compared to the previous year under the shortened yel-

low By contrast, there has been no reduction in the number of alleged violations at the twelve other red light camera locations in the city. The safety impact has also been positive.

"Since January 2016, there have been a total of 17 accidents at the intersection," staff noted. "Since the pilot program began at this intersection in April 2018, there have been four accidents reported."

Councilman Keely G. Briggs called for the pilot project. City staff revealed the data about the improvement at the intersection at her request. In other jurisdictions, municipal officials have resisted extending yellow light times. For that reason, the states of Georgia and Ohio mandated an extra second of yellow at every location equipped with a red light camera. Once the law was implemented, Georgia's red light violations immediately plunged between 70 and 80 percent, and in Ohio violations likewise plummeted as drivers had more time to get through intersections safely. The benefits did not decline over time, as TheNewspaper documented with a review of four years of data. Similar findings have been made in Chandler, Arizona and San Carlos, California.

'GREEN NEW DEAL' SEEKS TO OUT-LAW GAS-POWERED VEHICLES AND **GASSY COWS** 

In very broad strokes, the Green New Deal legislation laid out by Congressional Democrats sets goals for some drastic measures to cut carbon emissions across the economy, from electricity generation to transportation to agriculture.

The nonbinding resolution calls for "10year national mobilizations" toward accomplishing a series of objectives that the legislation lays out. Among the most prominent, the deal calls for "meeting 100 percent of the power demand in the United States through clean, renewable, and zeroemission energy sources." The ultimate goal is to eliminate fossil fuels, shifting away from oil, coal and nuclear power, in favor of eco-friendly energy such as wind and solar power.

The Green New Deal calls for "replacing non-essential individual means of transport with high-quality and modern mass transit," which is a flowery way of calling for a ban on gas-powered passenger cars, trucks and motorcycles, as well as air-

According to the legislation, within the

decade;

- Achieve a net-zero carbon economy with 100% clean renewable energy
- Eliminate internal combustion engines and expand electric car manufacturing
- Overhaul transportation systems and make air travel obsolete by expanding high-speed rail
- Retrofit all existing buildings for energy
- Work with farmers "to eliminate pollution and greenhouse gas emissions" such as cow farts
- "Economic security" for all, including higher education, jobs, wages, housing and health care

In short, the legislative framework combines climate-change-related ideas with a "dream" list of progressive economic proposals that would affect every American and overhaul the U.S. economy, all at an initial estimated cost of up to \$6.6 trillion a year over the decade.

Importantly, the bill, introduced on Feb 7 by Rep. Alexandria Ocasio-Cortez (D-NY), is a nonbinding resolution, so even if it were to pass it wouldn't itself create any new programs but would instead establish a lofty set of ideals the House should pursue in the coming years.

NUMBER OF AMERICAN HOUSE-HOLDS WITH MOTORCYCLES IS ON THE RISE

More U.S. households than ever before now own one or more motorcycles. A recent study conducted by the Motorcycle Industry Council (MIC) shows that the number of American households with at least one motorcycle in their garage has reached 8.02% in 2018. According to the MIC, in decades of surveying, this is the highest percentage ever reached, and represents a 15.6-percent increase over 2014 (when ownership was 6.94%); an increase of more than 1.5 million homes.

"The household penetration numbers have always been among the most important figures to us," said MIC President and CEO Tim Buche. "We're certainly happy to see more homes that have a motorcycle. Riders who talk about motorcycling to friends and neighbors help to inspire people who don't

Out of an estimated 126,224,000 households in the United States, over 10 million now own (at least) one bike. In fact, the number of motorcycles per household has been calculated to average around 1.30, meaning some families own more than one

According to the MIC survey, the total number of motorcycles owned also reached record levels, jumping to 13,158,100 last year, an increase of more than 2.5 million

motorcycles compared to 2014, the last time the MIC conducted the survey. It is even higher than the previous record from 2009 (11,704,500), which followed a long period of high-volume new-bike sales.

The estimated number of motorcycles in use rose to 12,231,000 in 2018, an increase of more than 2 million since 2014. And that number was more than 1 million better than the record figure from 2009, when 11,015,105 motorcycles were in use.

"Modern motorcycles are high-quality machines, enabling the pre-owned market to be a key part of the overall growth in the motorcycle and rider population," said Jim Woodruff, secretary/treasurer of the MIC Board of Directors and COO of National Powersport Auctions. "The annual pre-owned market is actually three times larger than the new market. Used bikes appeal to many riders because there are so many options in terms of price and style."

The percentage of motorcycles in running order was down 3 percentage points, from 96.1% in 2014 to 93% in 2018. "As used units become a larger part of the overall motorcycle population, it's not surprising to see a slight decrease in the percentage of operating units," Woodruff said. "Our research shows that the average age of a pre-owned motorcycle sold in the U.S. is

approximately eight years old. Plus, vintage bikes are on trend now and many riders are keeping non-runners as part of their collection.

FEDERAL JUDGE SEEKS EXPERT OPINIONS ON MONGOLS PATCH

A federal judge presiding over the highprofile Mongols motorcycle club trial has put out a wide-ranging call for expert legal input on the implications of the government's unprecedented efforts to gain control of the trademarked insignia worn by club members.

After a Santa Ana, Calif. jury decided in December that the club must forfeit the trademark to its logo, U.S. District Judge David O. Carter's decision to solicit briefs from a variety of experts, including trademark attorneys, law school professors, civil rights organizations and think tanks, highlights the new legal ground being broken in the first-of-its-kind Mongols racketeering and forfeiture case, which has drawn national attention and is virtually guaranteed to go before the Ninth Circuit U.S. Court of Appeals and perhaps the U.S. Supreme Court.

The judge has yet to rule on key legal issues regarding the government's attempts to take the Mongols trademarks, including whether stripping the club of the rights to its patches or blocking riders from using them would constitute a violation of its members' First Amendment rights.

Unlike a typical racketeering case, in which specific members of an organization are charged with crimes, the sole defendant in the current legal battle is the Mongols organization itself. As a result, attorneys for the Mongols also requested the judge to ask legal experts to weigh in on whether an organization is capable of forming the intent to commit crimes.

Judge Carter is scheduled to hear arguments on Feb. 28 over whether the verdicts in the Mongols case should be tossed out over legal technicalities or on constitutional grounds, according to the Orange County Register.

MOTORSPORTS EXEMPTED FROM CONTROVERSIAL EU INSURANCE

REQUIREMENT

After extensive lobbying by numerous motorsport organizations, the European Parliament has agreed to exempt bike racing from the European Union's Motor Insurance Directive (MID, also known as Vnuk) which would have required all motorcycles to have a form of road traffic insurance, even if they were specialist vehicles not meant for the road.

As no insurance of this kind is commercially available, this could have seen the end of motorcycle racing as we know it across Europe.

IMCO, the European Parliament committee responsible for the MID, voted overwhelmingly in favor of exempting motorsports by a vote tally of 32 to two. During the discussion, members of IMCO adopted a report recommending excluding "vehicles intended exclusively for motorsports" as "these vehicles are generally covered by other forms of liability insurance."

The report also made clear that it was necessary a line should be drawn between 'in traffic' and 'non-traffic' situations.

The MID was proposed after Damijan Vnuk, a Slovenian farm worker, was knocked off a ladder by a tractor reversing across a farmyard. After this incident, it was decided that all vehicles, even those not destined for road use, should be insured.

The MCIA (Motorcycle Industry Association in Europe), together with U.K. bodies including the Auto Cycle Union, Motorsport Industry Association and Department for Transport lobbied against the European Parliament alongside the FIA, FIM and European Motorcycle Industry Association.

"This is great news and a big relief for motorsport of all types," said Tony Campbell, CEO of the MCIA. "The potential impact would have been catastrophic and likely to result in the end of motorsport as we know it."

There are still some legislative hurdles to overcome; including gaining the agreement of the EU Council, but a positive final verdict is expected later this year.

QUEBEC MAY OUTLAW MOTORCY-CLES DURING WINTER

Winter may not be the most convenient time to ride a motorcycle, particularly in snowy northern climates like in Canada, but it is possible, even in extremely cold temperatures. But buried within a proposed law is a provision that would ban motorcycles from the streets of Quebec completely during the winter months, according to Canada Moto Guide.

Since 2008, Quebec has required that all vehicles registered in the Canadian province be equipped with snow tires rated for severe snow and winter traction between December 15 and March 15. This effectively banned motorcycles from the street, until recently. Now there are motorcycle snow tires available that meet Quebec's winter tire qualifications, making it legal to take advantage of an unseasonably warm day and go for a ride. Even the Sûreté du Québec, the provincial police force, recommended that motorcycles equipped with proper winter tires be expressly permitted on the road during this time of year.

Included in Bill 165, a bill to "better define the vehicles covered by the mandatory use of winter tires," however, is a provision that could put an end to all winter riding under any circumstances. The bill reads, "In order to regulate such a practice, we are of the opinion that motorcycles and mopeds must be exempted from the application of section 440.1," the winter tire requirement. "In addition, it would be necessary to add a provision [to the safety code] to prohibit their use between December 15 and March 15."

In other words, if the bill becomes law, it wouldn't matter what tires were on a motorcycle during the winter -- it won't be allowed on the road no matter what. Another part of the bill proposes extending the winter tire requirement, and therefore the motorcycle ban, back two weeks to begin December 1.

With the advent of heated riding gear and motorcycle tires that meet all requirements for severe snow and winter traction, bikers can safely operate their machines yearround and legally comply with Quebec's existing law...so why not let them?

#### MADRID AND BARCELONA TO LIMIT TWO-WHEELER ACCESS

Entering the Spanish cities of Barcelona and Madrid on a motorcycle will now be a lot more difficult, as new rules designed to reduce congestion and pollution have

come into play.

Madrid features a number of APRs (Áreas de Prioridad Residencial), areas where non-residents are not allowed to drive, and speed limits on roads into the capital have been lowered in order to cut pollution. Until now, motorcycles have been exempt from any restrictions, but that has changed as of November 30, 2018. According to Spain's motorcycle association, the AMM (Asociación Mutua Motera), Madrid will extend its current APRs into one big APR. called Central Madrid. The new APR will cover practically the entire downtown area of Madrid and motorcycles will now be party to these new regulations.

Motorcycles that were registered before 2003 will be completely banned from the city centre (38.79% of motorcycles in Madrid are registered before 1 July 2003), whereas those registered after that date can only enter the city between 07.00-22.00h. People found to be riding a bike into the city outside these parameters will be fined 90 Euros (\$102.29 USD).

#### MOTORCYCLES COULD COMPETE IN THE OLYMPICS

Trials riding is an amazingly difficult sport requiring years of practice, peak athleticism, and incredible control, and it may soon be an Olympic-caliber sport if the International Motorcycling Federation has anything to say about it. The FIM is appealing to the International Olympic Committee to have Trial-E (trials riding on electric bikes) added as a sport to the 2024 Summer Olympics, which will be held in Paris, France. If it is successful, Trial-E will be the first officially-recognized Olympic motorsport.

New sports are being added to the Olympics every year. In 2020, the Tokyo Olympics will be the first time we will see baseball and softball, surfing, sports climbing, karate, and even skateboard, all officially included as Olympic sports. The current policy for inclusion of a sport, according to IOC, is that it be: youthfocused, equally accessible for men and women, sustainable, spectacular, practiced on all continents and requires no new infrastructure, so trials riding measures up to all of these requisite metrics.

Exposing hypocrisy is one of the most powerful weapons you can have in the fight for freedom. Here are some of the ways you can put

this rule into practice:

## **Call Out Hypocrisy**

All too often, anti-freedom supporters say one thing and doing another. Don't let them get away with it. If a lawmaker says they stand with motorcyclists but support legislation that would inhibit freedom of the road, call them out on it.

If a group says they care about motorcycle safety but support onesize-fits-all policies that do absolutely nothing for safety on the road, make your voice heard.

## **Adapt Your Messaging**

Think about why you hold the position you do on an issue. You can change how you talk about your

stance on an issue that forces your opponent to either agree with you or contradict themselves.

Fighting for safer roadways for all is an issue all would agree with and most motorcyclists agree that the ability to lane filter can reduce rear end collisions which is a leading cause of fatalities in our state. But when you are going up against most auto drivers, it's not the best approach.

Non-motorcyclists like to claim that their policies will reduce crashes for everyone. They want to ease congestion on the freeways.

Make them live up to those beliefs. Talk about how lane filtering has


reduced rear end crashes. Explain how the opportunity to filter would reduce not only traffic congestion but ultimately reduce smog and pollution which is better for the environment.

Now your opponents have two choices: agree with you or throw in their lot with the people who don't care about ideas to reduce fatalities.

Nothing destroys credibility like being exposed as a hypocrite. Don't be afraid to call your opponents out when they don't live up to their rules.







# **Announcing Our New Membership Pages**





## **Using Request To Speak**

Mike Infanzon Legislative Director

For those legislators who listen to citizen input, a major source of information is the testimony rendered at committee hearings, both in person and remotely. The following are instructions on how to provide opinions at committee hearings without being there physically.

NOTE: Testimony at hearings can only be done for bills that are scheduled for standing committee hearings (e.g. appropriations, education, etc.). For all bills, scheduled for hearings or not, one may provide citizen opinions via other methods, like e-mail, telephone, etc.

- 1. First, one must register. This has to be done at the capitol in Phoenix, using one of the various terminals available. Beginning in 2018, you may also register at the legislature satellite office in Tucson. Once registered, one may log in as often as desired, using one's home computer. To do so, this is the procedure to follow:
- 2. At your home computer, go to https://apps.azleg.gov/Account/SignO
- 3. Sign on using the e-mail address and password you used when you registered at the capitol.
- 4. Choose "New Request" from the Request to Speak menu.
- 5. You now have several options as to how to choose a bill on which to render your opinion, but the easiest

and fastest way to go is to enter the bill number at "Search Phrase", then click on the "search" button.

- 6. The search results page comes up
- 7. At the bottom right, click on "Add Request"
- 8. Choose your position from the three provided: For, Neutral, or Against.
- 9. Next, choose whether you actually want to be present at the hearing and speak. Your choices are: Yes, No, or Only if Necessary. Most of the time you will be choosing "No".
- 10. Next, go to the comments section and state your opinions, but this is optional. Keep in mind that these are public comments, for the record. Everyone has access to these comments. Anything you say can and will

be used against you in the court of public opinion.

11. Next, click on "Submit" and you are done. Now you can start the process again for the next bill you wish to render an opinion on.

Going through the 11 steps is a lot easier than it may seem when reading the instructions.



## From The Board Room

This month we have some very exciting news to start off the New Year. For the second time in less than 12 months we have a new chapter starting up. Marc Shultz of Superstition Harley-Davidson can give you the details of the new chapter he is starting ion Apache Junction so be sure to stop by, say hello, and say Thanks! That is awesome news and we are grateful to Marc for undertaking this effort.

Marc was, unfortunately, motivated by yet one more motorcycle rider killed on the road so we want to give him and his team, as much support as possible. Speaking of new members, last month our ABATE of AZ President, Jim Butsback, made a plea for new members. It is important to remember that this is an ongoing goal of ABATE. There are, by some reports I have seen, over 225,000 registered motorcycles in Arizona. Since most of us only own 1 motorcycle, that is a ton of riders/voters. ABATE of AZ does its very best to represent all of them, but it is much easier to do with as large a percentage of those riders as members as possible. We know 100% representation is not possible (wouldn't that be awesome) but the more members we have from this group, the better for all of us. So, please, listen to Jim and see if you can get one more member. Like he says, if we each get one, we double our numbers and THAT would be hard for any legislator to ignore.

In 2019, ABATE of AZ will be focusing

on our two most important goals; preserving our rights, and protecting our safety. The former is being handled extremely well by our Legislative Director as he coordinates with our Authorized Lobbyist, the ACMC Designated Lobbyist, and the MMA Lobby team. They have some major challenges to deal with this legislative session as we fend off a new tax disguised as a Registration Fee, yet another helmet bill, and try to get anti-profiling, lane filtering, and distracted driving bills passed.

On the safety side, we will be urging more of you to participate in the Motorcycle Awareness Program currently spearheaded by Jim Silk, our State Safety Officer. Jim has been working hard to spread the word at High School driver training programs about how to "Look Twice For Motorcycles". But this is not nearly enough, so we will be looking for ways to not only support but also enhance the MAP program. In addition, we are actively looking for ways to work with other organizations, such as AMSAF

(the presenters of the annual "Riding For The Long Haul" event), and others. The goal here is to actively pursue, through any means available, the goal of zero motorcycle fatalities on Arizona's highways. This, we realize, is a tall order. But it is the goal and, in my opinion, it is achievable. It will not be easy. It will mean working with many organizations, state and federal agencies, and motorcycle riders themselves, but, with your help and support, it is possible.

The next Board of Directors meeting will be held in Bullhead City, home of the newly formed Mohave Chapter, at the Loyal Order of Moose lodge, 2620 Miracle Mile, Bullhead City, AZ 86442 on March 24th at 1 PM. The meeting is open to members and non-members alike.

Until then, Ride Free, Ride Safe, Ride Endorsed!

# 9th Annual White Mountain Bike Rally

Hon-Dah Resort Casino & Conference Center held their 9th Annual White Mountain Bike Rally on June 22 & 23, 2018 in Pinetop, Arizona. Hon-Dah Resort Casino & Conference Center is owned and operated by the White Mountain Apache Tribe.

With elevations climbing to more than 11,000 feet, the White Mountains of northeastern Arizona are home to the largest stand of Ponderosa pines in the world, making for some of the most picture-perfect riding in Arizona.

If riding in the cool pines with blue skies wasn't enough incentive for some, maybe the \$3,000 in prize money for the Saturday Poker Run and another \$3,000 for the Bike Show was the reason nearly 1,500 riders and their families came up from the flatlands to ride in the mountains for the weekend.

For only a \$20 registration fee, Hon-Dah Resort offered two dinners, an event tshirt, beer garden, vendors and entertainment by Tommy James & the Shondells, as well as a performance by the Apache Crown Dancers. Poker Run stops included Greer, Eager, Alpine, Hannagan Meadows, Big Lake and then a return to the casino for a steak dinner and music under the stars.

The event organizer provided further info:

"This year we had a total of 1,282 registered riders (approximately 1,000 bikes) and 24 vendors. Riders came from ten different states to attend: Arizona, New Mexico, Colorado, Michigan, Florida, Oregon, Texas, California, Utah & South Dakota.

The Poker Run on Saturday was an approximately three and a half hour ride. On the run the riders hit elevations up to 10,000 ft. There were five poker stops and all the vendors graciously gave of their time to help this event. We hear nothing but wonderful things about the people at the stops. The poker stops included: Molly Butler's in Greer, Trail Riders Restaurant in Eagar, Ye Olde Tavern in Alpine, Hannigan Meadows and the final stop is Big Lake Tackle and

Supply. The ride is through beautiful Ponderosa pines, blue spruce trees and the beautiful White Mountain Apache Reservation.

The Poker Run paid \$1,000 for High Hand Rider and High Hand Passenger. Those winners were Russell McCoy of St. Johns, AZ and Deborah Katzman of Show Low, AZ. Lower Hand Rider pays \$500 for the Rider and Passenger. This year's winners were: Andrew Armijo of Las Cruces, NM. and Lynda Van Haren of Show Low, AZ.

When the riders returned they got to see the White Mountain Apache Crown Dancers perform. Hon-Dah Resort wanted to show their guests something unique to the White Mountain Apache Tribe that not very many people have had the pleasure to see.

Then we held the Bike Show; the show has five categories including: American, Metric, Vintage, Custom, Trike and the People's Choice. 1st Place pays \$250, 2nd Place \$175, 3rd Place \$125 and People's Choice wins \$250.

After a grilled ribeye dinner, the riders went to the concert by Tommy James and the Shondells. I have to say they were amazing!

In addition to the play book and "leave behinds", the MRF's 2019 Legislative & Regulatory Priorities is a working game plan on what's important to MRF members as we prepare to meet the next session of Congress. For more details on the 2019 Legislative & Regulatory Priorities, go to www.MRF.org.

On May 21, 2019, the MRF brings a

well-orchestrated counter attack on the siege against your rights, your motorcycle and your lifestyle back to where it all begins – Capitol Hill. As always, you are invited to join this group of dedicated and determined freedom fighters as we take our message directly to our friends and adversaries in Congress.

Thanks to you and the generosity of other MRF members, expenses for BITB 2018 were paid without taxing the MRF treasury. The ancillary costs for printing, permits, and related expenses are nearly \$5,000. We are once again appealing to your generosity and your belief that the MRF is on task with BITB.

When talking with members at the Meet of the Minds and Bikers inside the Beltway, I'm positive that you value your motorcycle and your freedom as much as I value mine. 

# Report: Fewer People Using Cell Phones Behind The Wheel

Fewer people are texting and chatting on their mobile phones while driving, a National Highway Traffic Safety Administration (NHTSA) report concluded last month. Between 2016 and 2017, handheld cell phone use dropped from 3.3 percent of drivers to 2.9 percent. This represents a dramatic reduction from the phone use peak of 6.2 percent in 2007.

The results were gathered in a nation-wide observational study in which researchers peered into 50,577 cars as they pulled up to 1600 randomly selected stop lights during daylight hours. Trained observers also noted each time a

motorist was seen with phone in hand or otherwise visibly fiddling with the device. They also checked whether drivers were using headsets behind the wheel. The same methods are used in federal surveys to measure usage of seatbelts, child seats and motorcycle helmets.

According to the subjective assessment of the observers, the combination of factors most likely to result in cell phone use behind the wheel would be a very young, black female driving alone in a pickup truck in the Midwestern city during a light rain. By contrast, elderly males of "other" non-white races rarely used phones while driving cars in the rural Northeast.

The observational results are broadly consistent with a report NHTSA issued last year on public attitudes toward driving and cell phone use. A telephone survey found 9 percent of drivers admitted that they sometimes text behind the wheel, while 11 percent said that they do so, but rarely. Most explained that they do this while stopped at a light, and 19 percent use voice recognition to dictate the message without using their hands.

Sixteen states ban driving with a cell phone in hand. Texting and driving is banned everywhere except Arizona, Missouri and Montana. Only about half of frequent texters thought they were likely to actually receive a ticket for

their conduct. Half of the total respondents explained they had bluetooth in their car to make hands-free calls. About 57 percent reported that they never or only rarely answer their phone while driving.

Among drivers over the age of 65, 98 percent said they never text and drive. Among those aged 16 to 20, 4.8 percent said they always or almost always do -- the figure includes voice dictation and texting at a stop light.





## Virginia Lawmakers Quietly Enact Speed Camera Law

Speed cameras will soon appear on Virginia freeways under legislation that cleared the General Assembly on Wednesday. That leaves the final decision on implementing cameras to Governor Ralph Northam (D), who is currently embroiled in scandal from the discovery of his medical school yearbook photographs that show him appearing either in blackface or a Klu Klux Klan uniform.

Assuming the bill obtains Northam's signature, the state police will have the authority to set up automated speed traps in highway work zones beginning July 1. In these locations, a private company would mail \$125 tickets to the owners of vehicles photographed exceeding speed limit -- typically lowered in these locations -- by 12 MPH. The measure envisions the program would use handheld

laser speed cameras of the sort now used in Ohio and Tennessee.

The legislation was authored by state Senator Bill Carrico (R-Galax), a recipient of campaign cash from camera provider American Traffic Solutions (ATS, now Verra Mobility). While Carrico's attempt to pass the bill failed last year, it sailed through without any public notice shortly after the General Assembly convened last month. Carrico's Twitter feed, for instance, made no mention of his signature bill clearing the Senate with a 28 to 12 vote. The House of Delegates was equally enthusiastic and photo ticketing, approving the measure 74 to 24.

Carrico's measure allows the Virginia State Police -- his former employer -- to keep up to \$37 million in net profit from the program for each budgetary cycle. The agency will likely have no problem reaching that goal as neighboring Maryland, where photo tickets are only \$40 each, rakes in \$28 million annually in highway work zones. Conduent, the private company that runs Maryland's program, stands to make \$40 million over the life of the contract.

Virginia officials have been trying to get speed cameras on the road for more than a quarter century. In 1993, the agency partnered with Maryland in testing speed camera use on the Capital Beltway. At the time, the Virginia Department of Transportation found the radar equipment would read between 3 MPH and 9 MPH too high when operators deliberately positioned the cameras 8 degrees away from the recommended orientation.

Prior to this legislation's passage, Virginia only allowed private contractors to operate red light cameras, but payment of red

light camera tickets that arrive in the mail has been optional. State law requires inperson service before a ticket can be enforced. The new law states that speed camera ticket recipients outside of Virginia will face "all legal collections activities" if they fail to pay up. As a result of a nationwide settlement, however, it is no longer legal for credit reporting agencies to allow unpaid citations to affect a motorist's credit rating.

Twelve years ago ago, the General Assembly attempted to shore up funding by boosting the cost of speeding tickets to a maximum of \$3550 each through "abuser fees." After the public learned about the abuser fee law and expressed outrage, the state was forced to not only repeal the fees but also to refund all fees already paid.
