ethnic status of such individual. Many communities have adopted laws to deal with this illegal practice, and some make racial profiling training available to their law enforcement agencies.

Racial profiling laws are generally adopted voluntarily and vary by locality. For example, racial profiling laws may require law enforcement officers to report certain information for analysis, such as:

• The name, address, gender, and the officer's subjective determination of the race of the person stopped; Caucasian, African-American, Hispanic, Native American/Alaska Native, or Asian/Pacific Islander.

• Alleged traffic violation that led to the stop of the motorist.

My best advice is to know what profiling is and what it isn't.

If you are speeding... expect to be stopped. If you disregard traffic laws ... expect to be stopped. If you ride around like a dumb@\$\$... expect to be stopped. This is NOT profiling.

Now if you are stopped without any precursory reasons, then that might be profiling.

There are two sides to this. Motorcyclists want to stop being profiled. We can all agree on this. Then we need to police ourselves. Don't let your riding buddies be idiots and cause all motorcyclists to get a bad name. I had a discussion with a person high up in the state government recently and he complained about the idiot bikers splitting lanes and riding wheelies. He lumped all motorcycle riders into one group because of ONE rider being an idiot and breaking the law.

Is profiling legal? Police powers to stop and search vary from place to place. But ethnic or racial profiling—the targeting of specific individuals or groups based on appearance—constitutes illegal discrimination under U.S., European, and international law. But what about the way a person dresses?

Profiling refers to the law enforcement practice of the detention, interdiction, or other disparate treatment of an individual on the basis of the racial or • The make and year of the vehicle stopped.

- The date and time of stop.
- The location of the stop.

• Whether or not a search contemporaneous to the stop was conducted of the vehicle, driver, passenger, and if so whether it was with consent or by other means.

• The name and badge number of the issuing officer.

Racial profiling has been declared unconstitutional, as it is a violation of the U.S. Constitution's 14th Amendment equal protection clause. However, criminal profiling is legal and often used by law enforcement to apprehend criminals. So how does law enforcement get away with the supposed illegalities of profiling?

Criminal profiling is used by many police agencies and even the FBI because it benefits law enforcement and protection of citizens. However, to avoid problems and concerns, criminal profiling must be used with caution. But that's a discussion for I've had numerous conversations with law enforcement over the past 4 years as your legislative director. I have tried to bridge the gap for us and have a good relationship with the police community. I tell them "I want my friends to not die on the street and I don't want you to clean up the mess if they do." We can agree on that!

There are so many safety issues we as a community need to get done in the next few years. If would be a great thing if we had law enforcement tell legislators that we are trying to fix ourselves before pointing our fingers at others. We need to hold each other accountable. Be your brothers keeper.



users. Manufacturers must also include human error analysis in safety reports; and

AV manufacturers must report incidents between AVs and motorcycles just as they would incidents between AVs and other road users. Manufacturers must also include human error analysis in crash data and reporting.

Transportation Bill – The Senate Public Works Committee began the long process

of crafting a transportation and infrastructure bill. The ball is then passed to the Senate Commerce Committee which has jurisdiction over NTSHA. This is where the motorcycle provisions like "funding for motorcycle only check points" will be considered. We have reached out to Senate Commerce Committee members and will do so with their colleagues in the House. This will likely be an important area where specific SMROs can be helpful with the targeted asked of their lawmakers. The timetable on a transportation bill is always moving but we are prepared to be part of the discussion whenever legislation is undertaken.

This Year We Will Be Electing New State Officers

Many of our members have asked what the qualifications are for a State Officer and how long the term is etc. Our election will be held in November and we are now accepting nominations for State Officers. The following is the printout from the State By-Laws as to the State Officer Qualifications and term. If anyone is interested in running please contact Jim Butsback or any of the State Officers for more information.

(a) ENUMERATION: The Corporation shall have a President (designated as the "President"), one Vice President (designated as the "Vice President"), one Sergeant-At Arms, a Secretary (as that term is described in Arizona Revised Statutes 10-1002 (24)), a Treasurer, a Political Action Coordinator, a Membership Coordinator, and such other officers and agents as the Board of Directors may deem desirable.

(b) ELECTION; QUALIFICATIONS;

a chapter. Each officer shall hold office for the term for which he is elected or appointed and until his successor has been elected or qualified and appointed. The members of the Corporation shall elect officers at their annual meeting. State officers, with the exception of the State Treasurer, who is appointed by the Board, shall hold office for a term of two (2) years. All State officers and the Board of Directors shall maintain a membership with the American Motorcyclist Association (A.M.A.) through the tion of their term of office, to ensure the Corporation's Charter Status with A.M.A. Any two or more offices may be held by the same person, expect that the President and the Treasurer shall not be the same

person. With the exception of the State Treasurer, members of the Corporation may submit to the Corporation candidates who are members of the Corporation for its consideration to elect as an officer of the Corporation. No member of the Corporation shall hold a position as State Officer and member of the Board of Directors concurrently.

(2) The Board of Directors may, at its discretion, qualify a candidate with equivalent officer experience from an ABATE organization from another state, provided the candidate meets the other provisions of Article 6.01 (b) (1) above.

6.01 NUMBER; TITLE; ELECTION; TERM:

Honda at 40: Company, original employee grew together

When Honda celebrated its 40th anniversary in Ohio this week, the milestone carried special meaning for employee Neil Vining.

Vining was 22 in 1979 when he landed a job at a new motorcycle factory Honda was opening in Marysville.

Today, Vining is a chief engineer at Honda. He is one of two employees still at Honda who were there when Honda of America opened its first U.S. operation in Ohio.

Vining's journey with Honda is an illus-

In March, 1979, he had his chance and interviewed for a position, not knowing what to expect. After all, there was no track record of Japanese automotive manufacturers in the U.S.

"Remember that the Japanese automotive industry was initially considered a curiosity. They made econoboxes no one wanted," said Giorgio Rizzoni, director of the Center for Automotive Research at Ohio State University.

"Then they became real competitors to Detroit. For a long time, there was quite a bit of resentment in regard to Japanese automakers in the U.S. But Honda managed this transition in an extremely elegant way."

Three months after he interviewed,

impression magnified by the ubiquitous white uniforms — and received another clue that this was a different company.

"Within the third or fourth week of working here, they asked, 'Where would you like to be in a few years at Honda?'" Vining said. "That's was a surprise. I don't think people recognized the potential the company had."

That approach was revolutionary in an industry famous for labor-management battles.

"There's a culture at Honda where every individual, no matter what their rank, every voice counts, everyone wears the Honda white and every voice is important," Rizzoni said. "Everyone is encouraged to speak up to look for ways for engine plant in Anna, in 1985; a second assembly line in 1986; a second automotive plant, in East Liberty, in 1989; a transmissions plant, in Russells Point, in 1996; and the Performance Manufacturing Center, in 2016.

Honda's initial investment of \$35 million in the motorcycle plant was dwarfed over the decades. The company now estimates its total Ohio investment at \$11 billion. Those 64 original Ohio workers grew to 15,000 in Ohio and 25,000 throughout the U.S.

Over the years, motorcycles were joined by a string of Hondas and Acuras, including Vining's favorite, the Acura NSX performance car. Together, the three Ohio plants have turned out more than 20 million vehicles. (The motorcycle plant

tration of the company's journey.

Like many Americans, Vining didn't know what to expect from the company. By the 1970s, Japanese cars and motorcycles were well-established among consumers, but not among employees.

Vining worked at Tecumseh's Marion factory but was weary of the laid-off, backto-work cycle of the plant. (Tecumseh closed the factory in 1984.) He was curious about Honda, which he had followed in the newspaper since the manufacturer announced in October 1977 that it would build a factory in Ohio.

"Every week I watched the paper looking for that final notice about when I could send my application," said Vining, who had bought his first Honda motorcycle when he was 16. Vining was hired and almost immediately discovered this job would be different.

"I was at my girlfriend's house on a Sunday afternoon and they called and asked if I could go to Japan," he recalled. "I really wasn't expecting that."

Vining grew up on a farm near Ostrander and had graduated from Buckeye Valley High School in 1975. He had never been out of the country.

After learning how to weld motorcycles in Japan, Vining returned to Ohio to help install equipment that would be used to turn out Honda's Elsinore CR 250 motorcycle. The first cycle rolled off the line Sept. 10, 1979, a modest start to Honda's U.S. journey.

Vining recalls how unusually clean and orderly the assembly line seemed — an

improvement."

On the day the Elsinore came off the line, Honda announced it was building an automotive assembly plant near the Marysville motorcycle plant.

"When I realized it was going to be a career for me was on our initial launch date of Sept. 10," Vining said. "That day our president announced that they would start the auto plant, so we knew it was going to be around for a while."

Vining helped install equipment for the plant, and shifted to the auto line to help launch the first U.S.-built Honda Accord in November 1982, the first car built in the U.S. by any Japanese manufacturer.

That plant launched decades of growth for the manufacturer in Ohio: a research and development facility in 1985; an closed in 2009.)

As Honda grew, so did Vining. He worked on the automotive line until 1990, when he was assigned to plant engineering, examining manufacturing capacity in Ohio and beyond. Far from the wide-eyed country kid on his first trip overseas, Vining has now traveled to Japan 20 times.

Vining and his wife, Tami, continue to grow soybeans on their Ostrander farm and he is starting to ponder life after Honda.

"How often in your life do you get a chance to work with a team of people to build something important?" Vining said. "Honda also built me, so when you talk about retirement, and the next adventure, I feel like I have a lot of experience now that I can use to help people." JUDGE DISMISSES COUNTY AS DEFENDANT IN TWIN PEAKS LAW-SUIT

A federal judge has dismissed McLennan County as a defendant in a civil rights lawsuit filed by three bikers arrested after the 2015 Twin Peaks shootout, but ruled the plaintiffs can pursue claims against the city of Waco and seven individual defendants.

The lawsuit, filed by the three bikers who were never indicted in the deadly shootout with law enforcement, is one of about 20 pending Twin Peaks civil lawsuits involving about 130 bikers with claims of unlawful arrest and conspiracy.

The plaintiffs allege former McLennan County District Attorney Abel Reyna was the final policymaker for McLennan County regarding the events at Twin Peaks, but U.S. District Judge Alan Albright ruled that a county sheriff, not the district attorney, is the final policymaker.

The lawsuit alleges Reyna was the county's final policymaker because he "was responsible for devising the overall prosecutorial goals and strategies" of the county on the day of the shootout that left nine bikers dead and 20 injured in a hail of police gunfire, but the judge ruled that "regardless of Reyna's involvement in

"regardless of Reyna's involvement in helping to decide whether the arrests should be made, he did not have authority to make municipal policy."

The judge denied the city's motion to dismiss the lawsuit. The order leaves claims pending against D.A. Reyna, as well as the former Waco police chief, assistant chief and various named officers.

More than 200 bikers were jailed on identical arrest warrant allegations. Only one case went to trial, which ended in a hung jury favoring acquittal and a mistrial. District Attorney Barry Johnson, Reyna's successor, dismissed the remaining charges against the bikers.

According to a report by Tommy Witherspoon in Insane Throttle Biker News (www.harleyliberty.com), the lawsuits allege the defendants violated the bikers' Fourth Amendment rights by obtaining arrest warrants based on a fillin-the-name affidavit that lacked probable cause. They also allege defendants violated their 14th Amendment due process right to be free from unlawful arrest.

Insane Throttle was recently awarded the Silver Spoke Award for Media at the 2019 National Coalition of Motorcyclists' NCOM Convention in Orlando, Florida.

PROPOSED IOWA ORDINANCE

WOULD ALLOW ATVs ON COUNTY

A committee in Linn County, Iowa is working to pass a new ordinance that will allow ATVs to be driven on county roads, despite concerns about having off-road vehicles sharing the streets with regular vehicles.

County Supervisor Brent Oleson said a committee approached him about the ordinance, saying that "I'm all for not taking anything off the table, anything that gets people outdoors can only have positive benefits."

But Sheriff Brian Gardner told TV9 that combining ATVs and regular vehicles on the same road is just too dangerous. "They're off-road vehicles, and they're designated as off-road vehicles for a reason."

Oleson says they're going to look at what works for ATV ordinances in other areas, and hopes to have something passed before spring.

Right now, unless a town or county passes an ordinance allowing it, ATVs can only be driven on one of Iowa's eight riding parks or on private property. ATVs are also allowed to cross streets, with some restrictions.

VIRGINIA BECOMES 15TH STATE TO CREATE AN OFFICE OF OUTDOOR RECREATION Virginia Governor Ralph Northam (D) has announced the creation of an Office of Outdoor Recreation to lead efforts to promote the outdoor recreation industry in Virginia and recruit new outdoor businesses to the Commonwealth.

The outdoor recreation industry contributes nearly \$22 billion annually to the Virginia economy, and employs more than 197,000 Virginians. Virginia will be the 15th state in the nation to establish an office or task force dedicated to strengthening the outdoor industry, and the third on the East Coast.

"Every region of our Commonwealth is home to unique outdoor assets and recreation opportunities, which continue to earn national praise and are sought out by millions of travelers each year," Gov. Northam said. "In establishing a statewide Office of Outdoor Recreation, we are taking significant steps to recognize the importance of this industry as a true driver of economic development in the Commonwealth, and demonstrate why Virginia is the natural fit for outdoor business. Outdoor recreation not only improves the growth potential of our communities, but it also aligns with our goals on land conservation, workforce development, and public health."

NATIONWIDE MOTORCYCLE THEFTS DECREASING

While motorcycle theft has been a significant problem in the US, the latest National Insurance Crime Bureau report indicates that motorcycle thefts across the country went down in 2018, and in fact have been on a steady decline since 2016 after experiencing an uptick the previous two years.

A total of 41,674 motorcycles were reported stolen in 2018 compared with 44,268 reported stolen in 2017 -- a decrease of six percent.

By manufacturer, Honda was the most stolen bike brand, followed by Yamaha, Suzuki, and Kawasaki. Harley-Davidson rounded out the top five.

Unsurprisingly, motorcycle thefts in the US are at their peak during the summer months, with August, July, and September, in that order, seeing the highest number of thefts, and with about half as many bikes stolen in February 2018.

The report also gives a state-by-state breakdown, and notes that thefts are more common in large metropolitan areas as well. California leads the country in motorcycle thefts, with 7,035 occurring in 2018, followed by Florida with 4,279 thefts reported, then Texas (3,073), New York (1,777) and South Carolina (1,743). By city, New York City led the way with 1,310, then Los Angeles with 628, Miami (595), Las Vegas (540), and San Diego fifth with 527

A total of 16,261 bikes were recovered from thieves in 2018, or about 44% of those stolen.

STUDY SHOWS MOTORCYCLES MOST LIKELY VEHICLE TYPE IN U.K. TO BE STOLEN

One in every 46 registered motorcycles in the United Kingdom (UK) was stolen last year, according to new figures gained by a Freedom of Information (FOI)

request by the Motorcycle Action Group (MAG). In London, one in every 12 bikes was reported stolen in 2018.

While the countrywide figure actually signals a modest 3.98% improvement over 2017, the national average of one in 46 still means that motorcycles are seven times more likely to be stolen than any other road vehicle!

"For a biker, the theft of their bike is definitely not a victimless crime," said Colin Brown, MAG's Director of Campaigns & Political Engagement. "More so than for any other mode of transport, riders become emotionally attached to their bikes. For some, the loss of a bike is akin to the loss of a family member."

With an average 500 bikes stolen a week in 2018 motorcycles remain the most commonly stolen vehicle in the UK, seven times more likely to be nicked than anything else, which is why security firms are coming up with ever-more sophisticated locks.

NEW HAMPSHIRE TO MODERNIZE DMV IN WAKE OF DEADLY JUNE CRASH

Following the deadly June 2019 crash that killed seven motorcyclists in New Hampshire, officials want to work with other states to prevent anything like this from happening ever again.

The truck driver currently facing seven charges of negligent homicide in those deaths -- who had a Massachusetts-issued CDL -- should not even have been driving, according to his combined driving record. The head of the Massachusetts DMV resigned and others at the agency were fired once this came to light.

Over the past few weeks, New Hampshire has also been conducting an internal review of its own DMV records and practices. On August 29, 2019, NH governor Chris Sununu gave a press conference with other top officials to share their findings. The results: nearly 4,000 drivers will have their licenses suspended following a review of over 13,000 out-ofstate notices, as well as a backlog of 62 commercial license notices dating back to

2016.

One unintended and potentially good consequence of this terrible accident is that it's led New Hampshire to modernize its DMV system and automate notices, so that paper backlogs like this can't build up in the future. Additionally, the governor is now pushing the state legislature to allow the NH DMV to become part of a computerized state-tostate driver verification system using Real ID.

One of the biggest issues that the terrible crash brought to light is that truck driver Volodymyr Zhukovskyy had a number of driving offenses spread across multiple states -- that obviously didn't communicate effectively with one another. Creating processes that enhance communication of driving offenses across state lines seems like a logical step toward preventing catastrophes like this in the future.

EURO5 EMISSIONS RULES EXPECT-ED TO BRING TECH PROGRESS The latest European emissions limits (Euro5) will be introduced from the start of next year on, and while many naysayers preach gloom about tightening emissions laws, others predict that they will spur development, creating bikes that are measurably better than their predecessors.

Euro5 is the fifth iteration of European emissions limits that have got steadily stricter since the original Euro1 came in 1999, and the newest limits represent an astounding improvement over the two decades since: compared to the current Euro4 limits, Euro5 levels are down by a third.

The big news is the introduction of a limit for 'non- methane hydrocarbons' (NMHC) -- quite literally hydrocarbons that aren't methane -- which wasn't measured before. NMHC makes up most of a bike's HC emissions, so the 0.068g/km limit is a particular challenge. To reduce HC emissions in high-revving performance engines as well as at low revs, expect to see an explosion in the use of variable valve timing (VVT) as

well as higher capacity engines to reduce reliance on higher revs; both of which will boost performance.

On the downside, as the bikes get more impressive, they'll also be more complicated, making them more costly to produce, and making maintenance more expensive.

As before, Euro5's introduction is staged. New models from January 1, 2020 must meet the limits but manufacturers have an extra 12 months to adapt existing designs.

Brexit won't exclude the UK from compliance, as they're already committed to remaining aligned with EU rules and other non-EU countries such as India and China are adopting similar standards.

FRENCH ROLL OUT 'NOISE CAM-ERAS

France has begun tackling loud motorcycle exhausts, by installing a 'noise radar' capable of identifying the offending vehicle, with the device linked to Police CCTV cameras in order to automatically issue fines.

In the UK, the Department for Transport has likewise announced that they will be trialing new 'noise cameras' in a bid to cut down on illegal exhausts.

WHY SHOULD WE CARE? WHAT CAN WE DO?

Alinsky's Rules for Radicals #11: "If you push a negative hard and deep enough, it will break through into its counterside"

To explain his eleventh rule, Saul Alinksy tells a story about his time as a grassroots organizer. When he was organizing activists against a corporation, the corporation hired people to break into his home and his organizations' office and steal the documents and records Alinksy and his allies had put together about the corporation.

Losing all of those documents could have been a huge setback to Alinsky's cause. The stolen records likely represented countless hours of work. Even worse, now his opposition had his entire strategy.

Instead, Alinsky found a way to turn the

negative into a positive. "When a corporation bungles like the one that burglarized my home and office, my visible public reaction is shock, horror, and moral outrage." Spreading the word about the break-in made Alinsky and his allies the victims and helped paint their opponents in a bad light.

In addition, Alinsky made sure his opponents knew they would be testifying in front of Congress about the corporation's misdeeds they had been trying to cover up. "This threat, plus the fact that an attempt on my life had been made in Southern California, had the corporation on a spot where it would be publicly suspect in the event of assassination," Alinsky wrote in Rules for Radicals.

Alinsky had hamstrung his opposition. If

the corporation continued their harassment and intimidation campaign, they would be even further incriminated. The more they did to oppose Alinsky, the more power they gave him.

Alinsky was right. Almost every negative attack against you can be turned into a positive with the right tactics.

A few years ago, a motorcyclist was arrested for criminal trespassing at the Mesa court house because he would not change his toy run t-shirt. There was no "gang affiliation", vulgarity or nudity on the t-shirt. It was a blatant attempt of the security at the courthouse to intimidate this person. Multiple emails to the senior jurists not only in the Mesa court system but in the state judiciary resulted in attacks on motorcyclists over social media from certain individuals in public service. These tweets and messages were then sent to the local media. The media coverage the tweets received helped highlight how motorcyclists are profiled in a negative light and how cruel the attacks on freedom had been and made those who were discriminating against the freedom to wear a TOY RUN shirt look even worse. Because of this, we were able to use the negative and get the profiling memorial passed unanimously this last session.

You can use this tactic when you're leading issue campaigns. When you or your cause get attacked, take the time to think about how you can turn the negatives into positives. The worst attacks against you can wind up being your best assets.





Hunter Sills Racing Earns Four World Records and One U.S. National Record at the AMA

Hunter Sills Racing captured five records with its BMW S 1000 RR at the Bonneville Salt Flats in Wendover, Utah, during the Bonneville Motorcycle Speed Trials event held Aug. 24–29, 2019. The team also earned Top Time of the Meet and Fastest Naturally Aspirated Motorcycle and increased the speed of their world's fastest BMW motorcycle to 238.398 mph. Both riders, Erin Sills and Trev Richter of Hunter Sills Racing, earned 1000cc FIM records aboard a nitrous-powered BMW bike affectionately known as "Snoopy." said Sills, rider and owner of Hunter Sills Racing. "Shane Kinderis of Alpine Performance Centre put together an incredible motor which performed beautifully with the Wizards of NoS nitrous system. I also found the AirTech fairing to be incredibly stable and grounded at speed."

"Our senior race technician Curtice Thom worked alongside Shane Kinderis again, a pairing that has proven to be very successful over the years. They did an excellent job of keeping the bike in peak performance, and I'm very pleased with our results. As always, we owe a great amount of success with this project to our many technical partners," added Gary Orr, owner of San Diego BMW Motorcycles and Hunter Sills Racing team member. National records in my first event," said Richter.

Hunter Sills Racing is also proud of its contributions to the Bonneville Motorcycle Speed Trials racing community during the week. With the express permission of the Bureau of Land Management, the team built and donated a mock "Bonneville Salt Flats" sign which was installed at the entrance of the Salt Flats for the week-long event. Following the event, HSR auctioned the sign, earning \$4,000 to benefit a fallen rider who needed help with medical bills. Erin Sills also continued her Shemoto Scholarship, awarding \$2,000 to the Buell Sisters team of Ashley Woodford. About Hunter Sills Racing:

Hunter Sills Racing is a female-owned professional land speed racing team including motor builder Shane Kinderis of Alpine Performance Centre, Gary Orr of San Diego BMW Motorcycles, race technician Curtice Thom, and riders Erin Sills and Trev Richter. The team races in memory of the late Andy Sills. Together, the team has earned over 40 World and National records, two Guinness World Book records, Mojave Mile 200 MPH Club membership, Mojave Magnum 200 MPH Club membership, BUB 201 MPH Club membership, Bonneville SCTA 200 MPH Club membership, El Mirage SCTA 200 MPH Club membership, top average mile speed to-date of 238 MPH, and title of World's Fastest BMW. When not racing the Salt Flats, Richter and Sills both serve as off-road adventure motorcycle riding coaches. Erin Sills has been named 2013 Advertising Age Woman To Watch, 2014 American Motorcyclist Association Female Athlete of the Year, 2014 University of Cincinnati Lindner College of Business Distinguished Alumni and is a retired executive with Facebook, Inc. A frequent speaker on behalf of the sport of motorcycling, Sills also serves on the board of directors for the American Motorcyclist Association Hall of Fame Foundation, the FIM Women's Commission, WomenRidersNow.com and is the founder of the Shemoto Scholarship for females in the sport.

With improving track conditions over the week, the team was able to set records early, then progressively improve them over the event. Ultimately, Sills piloted the Alpine Performance Centre-built BMW S 1000 RR to 237.287 mph to earn the FIM kilometer record in the faired, naturally aspirated 1000cc class; a record that was previously set in 2014 by her late husband Andy Sills, also of Hunter Sills Racing, at 221.863 mph. Erin was later able to improve her own FIM mile record set in 2018 on the Uyuni Salt Flats in Bolivia at 229.265 mph, making the new mark 236.889 mph. "After the poor track conditions presented by Mother Nature during Speedweek, we were looking forward to seeing how our bike would perform on a better course,"

Richter, known previously for his "Race For Relief" charity effort World's Fastest BMW GS (http://huntersillsracing.com/race-forrelief-2018/), also saw much success in his first event racing the BMW S 1000 RR, winning back a record the team lost in Bolivia in 2017 to Nick Genet. Richter increased the FIM and AMA 1000cc naturally aspirated un-faired ("naked") mile record to 195.674 mph and the FIM kilometer record to 196.206 mph.

"Riding the over 275 horsepower motorcycle without a fairing presents a unique physical challenge, but the team gave me a bike and suspension set-up that enabled me to reach my goal of earning World and The next event for Hunter Sills Racing will be in support of the Women Riders World Relay, a year-long around-the-world journey of over 10,000 female motorcyclists. Erin Sills will participate in the WRWR's United States relay Oct. 2-12, 2019.

Utah Police Admit They Profile MC Members

Motorcycle profiling is an issue that knows no state bounds. From coast to coast, police and other governmental agencies are violating the constitutional rights of Motorcycle Club members. Typical of this trend, six members of a motorcycle club in Utah were recently stopped on three separate occasions, all within an hour, simply for associating with what one sheriff supervisor referred to as a threat group. No traffic infractions were issued.

This incident is is just the most recent in the undeniable pattern of evidence. Motorcycle profiling is proliferating nationally. The best hope of combating this epidemic is cost free legislation at the state and federal level that prohibits the practice and provides a mechanism of relief for victims.

Start of the Night

Just after midnight on August 18, 2019, members of the Undefined Limits Motorcycle Club decided to go on a ride in beautiful Utah summer weather. Meeting at a Maverick gas station to pick a destination, MC members noticed two Utah police cars, carrying four officers, parked off in the distance. Member Buster, believing that a traffic stop was inevitable, waved the other members of the group to the front. At the first stop sign, a complete stop was made, and both feet were on the ground. Regardless, Buster and a hang-around of the club were pulled over for a stop sign violation.

First Stop

Buster and the hang- around were pulled for a stop sign violation. The two sheriffs approached the riders with their hands on their firearms, and demanded identification. After providing their drivers licenses, for his and his brother's safety, Buster informed the sheriffs that he was carrying a firearm, and had a legal CCW, even though no law in Utah dictates that holders are required to do so. The two riders were told to keep their hands on the handlebars, and keep their kickstands up, while one officer wrote the citation, and the other kept watch on the two riders. Thirty minutes into the stop, member Big Rig came back to the scene to check on the safety of his brothers. The sheriff demanded his identification since he "was on the scene." No citation was given to Big Rig. The total time for the simple traffic stop of the two individuals, took a total of forty-five minutes, a clear violation of his civil liberties, as outlined in Rodriguez v. United States.

Second Stop

After twenty minutes of waiting, several riders decided to head back in the direction of the Maverick Gas station. While pulling onto I-89, member Clash noticed a Utah police car sitting in the darkness with all of the lights off. Once the group passed the parked patrol car, the officer immediately pulled out and approached the group. Quickly the officer pulled over the rear rider, Clash, for an alleged turn signal violation. Clash was given a citation for an expired drivers license, and a warning for the turn signal violation. During the stop, the sheriff mentioned that the department had just "broken up" a party being held by another Motorcycle Club, and the sheriffs assumed the riders were coming from said party.

The Real Reason for the Stops

Club members Tech and R2 pull into the Maverick gas station and are immediately pulled over by one sheriff for yet another alleged turn signal violation. Member Tech asks to speak with a supervisor. Tech questioned the supervisor as the real reason for the stops, since six members were stopped in the previous forty-five to sixty minutes. The supervisor responds, " Why do you think? Why do you think? "Tech responds, "because we have this on?!", referring to his vest. A Utah Police Supervisor responds, "You are documented, ok. The (club name) are a documented threat group, that's how it is. So that's why we're doing this. That's why we're pulling people over," showing a clear bias and prejudice towards Motorcycle Club members. Neither rider was issued a citation, though both were given written warnings.

None of the six Club members had any registration or insurance verified by the Davis County Sheriffs, nor were any inspections stickers verified. This is one of the reasons the MPP believes this was nothing more than a intelligence gathering expedition.

Legislative Relief

The above events are just one more reason why legislative relief is needed in Utah, and across the country. The intrusions on individuals civil liberties, simply for expressing their 1st Amendment right to freely associate needs to stop. And as the MPP has demonstrated, Motorcycle Profiling bills are the correct avenue to take.



'Bullitt' Mustang auction-bound next January at Kissimmee sale

The Highland Green 1968 Mustang fastback that starred alongside Steve McQueen in Bullitt is, quite possibly, the most-recognized Ford Mustang on the planet, despite spending decades in the shadows. After returning to the spotlight in 2018, the car has made appearances at auto shows, museums, concours d'elegance events, and even on the National Mall in Washington, D.C. The Bullitt Mustang has been in the Kiernan family since 1974, but next January may well become the most expensive Mustang ever sold at auction when it crosses the stage during Mecum's Kissimmee, Florida, only one of the cars – chassis 559 – remained in salable condition, while the badly damaged stunt car, chassis 558, was sold for scrap. Long considered lost to history, chassis 558 surfaced early last year, rescued from a Mexican junkyard in 2016.

Chassis 559 was purchased by Warner Brothers employee Robert Ross, who kept the car for nearly two years before advertising it for sale in Hemmings Motor News in 1970. Its next owner, fittingly, was New Jersey police detective Frank Marranca, who reportedly paid Ross \$6,000 for the screen-used Mustang. Marranca kept the car until 1974, when it always the same; the car wasn't for sale, and they weren't interested in having the car featured in a magazine. Circa 2001, Robert and Sean began a restoration of the car, but the project didn't progress at the originally intended speed and was soon set aside.

Robert Kiernan died in 2014, passing the Mustang along to Sean. A year later, Sean let slip to his boss, Casey Wallace, that he was the owner of the car, prompting Wallace to enlist the help of friend and filmmaker Ken Horstmann to document the car's history. One minor detail delayed the start of the video's production: In 2015, the Bullitt Mustang was in pieces, the restoration begun in 2001 never completed. included the first Chrysler minivan (a 1984 Plymouth Voyager LE) and the Ferrari-replica Modena Spyder that appeared in Ferris Bueller's Day Off. In July 2018, the Bullitt Mustang appeared at the Goodwood Festival of Speed, where it was driven up the hill in pursuit of a black '68 Dodge Charger said to be used in the filming of the movie.

The decision to sell a car that's been a part of his family for 45 years could not have been an easy one for Sean, but it's worth remembering that the Bullitt Mustang is no ordinary collector car. The demands of ownership include constant appearance requests, the liabilities of shipping (in some cases, internationally), and, ironically, the inability to simply enjoy the car for the occasional drive without interruption or serious financial risk. Though some will view this as cashing in on the car's history, it's almost surely about returning to a normal life, albeit one with a comfortable reserve in the bank.

In January 1968, Warner Brothers purchased a pair of S-code Highland Green Mustang fastbacks, with sequential vehicle identification numbers, for use in the filming of the movie. Chassis 8R02S125558 was modified for use as the stunt car, while its twin, chassis 8R02S125559, was selected as the hero car, used primarily for close-ups. Both received chassis reinforcements, heavyduty front springs, Koni shocks and a thicker anti-roll bar, and their alreadypotent 390 V-8s gained machined heads, larger four-barrel carburetors and a hotter ignition for added performance.

From there, the paths of the two cars diverged. Chassis 558 received a roll bar that doubled as a camera mount, and a small generator (needed to power cameras and lights) was installed in its trunk. Once production of the movie wrapped, sold to Robert Kiernan for the same \$6,000 the detective had paid for it in 1970.

In 1977, Steve McQueen contacted the Kiernans looking to reacquire the Bullitt Mustang, which was then in use as a daily driver. An equivalent Mustang was offered in exchange (plus, presumably, some unspecified amount of cash), but the New Jersey couple opted to keep the Bullitt Mustang instead. In 1979, Robert's wife Robbie purchased "Bulitt" vanity plates for the couple's anniversary, and nearly 40 years later, these remain on the car.

In 1989, the Kiernans – now with nineyear-old son Sean – relocated to Kentucky, and then six years later, to Tennessee. Numerous Mustang collectors (and print publications) contacted the family over the years, inquiring about the Bullitt Mustang, but the answer was Instead of hastily restoring the irreplaceable Mustang, Sean instead opted to reassemble the car, which remains largely original throughout (its rebuilt and repainted 390 V-8 a notable exception). This task was completed in 2016, and on July 4, Sean fired the 390 V-8 for the first time in 15-plus years. In 2017, the Mustang was reunited with a member of the McQueen family – Molly McQueen, Steve's granddaughter – who met with Sean at a Ford design studio in Dearborn, Michigan.

Its reemergence came in January 2018, at the North American International Auto Show in Detroit, Michigan. Three months later, thanks to its place on the National Historic Vehicle Register, it was displayed on the National Mall, part of an Historic Vehicle Association exhibit that Dana Mecum announced the Bullitt Mustang's upcoming sale, alongside Sean Kiernan, at the firm's Monterey auction. No pre-auction estimate has been announced, though it's a safe bet that the sale will set a record for a Ford Mustang sold at auction.



Louisiana Appeals Court Upholds Class Action Against Red Light Cameras

New Orleans, Louisiana, will now have to pay back millions in illegally issued red light camera tickets. The state Court of Appeals last week found that the city broke the law by allowing American Traffic Solutions (ATS, now Verra Mobility) to issue tickets in 2008 under an ordinance that improperly placed authority for adjudicating tickets in the city's Department of Public Works (DPW). The New Orleans city charter specifies that all traffic regulation enforcement duties belong to the police department.

As I shopped the vendors' wares, more guests rumbled up in packs, V-twins pumping in time with the hard country feel of the Fryed Brothers Band. When their set was over I went in search of the band. A leather-clad bearded man offered me a smoke before I even got a word in. I politely declined, telling him that I was hoping to speak with Harry. He walked me straight into the cool conditioned air of the tour bus, where people were sipping long necked beers and getting a reprieve from the heat. Judges Paula A. Brown and Dale N. Atkins wrote in a concurring opinion.

Louisiana has a history of scandal with its automated ticketing machines. Jefferson Parish was caught allowing Redflex lobbyists to receive a 3.2 percent of the profit from each ticket. In New Orleans, the city inspector general uncovered an arrangement that allowed individual police officers to fill their own pockets with red light camera cash by "reviewing" citations while off the clock through a limited liability company.

The guys were sharing their best crash stories, which greatly amused me since I was still in a sling from my latest brush with pavement. I felt right at home with these gruff bikers. I asked Harry what he enjoyed most about playing locally, he stroked his beard thoughtfully and responded that it gives him a chance to visit with those who are dearest to him "except Tim!" he exclaimed as a grin curled across his face. Tim grinned back.

That's what it's all about, the people. Developing and cherishing those deep connections with your community. Harley-Davidson of Yuba City went above and beyond to facilitate a warm, inviting event that made it easy to feel like a part of the H-D family.

From The Board Room

During the last month I was able to meet with Mick Degn, Executive Director of AMSAF. Also attending the meeting was Joe Silk. For those of you who are not familiar, Joe and his brother Jim (State Safety Officer) run the Motorcycle Awareness Program (MAP) for ABATE of AZ. While the majority of the organization is often focused on legislation, Jim and Joe are quietly going about the business of educating high school students about the need to be aware of motorcycles on the road when driving. This is an EXTREMELY important part of what ABATE is about although it gets little attention. Jim and Joe are unsung heroes of ABATE of AZ and need our support and recognition. MAP was the primary focus of the meeting with Mick as ABATE of AZ and AMSAF to explore ways in which we can help each other. These idea-sharing meetings are proving quite useful for both organizations and we intend to keep doing them on a quarterly basis.

This is an excellent time to mention that, besides rider training scholarships, AMSAF is introducing a new program to provide huge subsidies on helmets from major manufacturers. If you are interested in a new (or even your first) helmet, check out AMSAF.org for more information, or look for their ad elsewhere in this publication.

The MAP program probably does more to save lives than anything else ABATE of AZ currently does. In the past, it was a much larger piece of the puzzle with MAP-certified instructors helping out and doing training sessions in parts of the state other than just the Phoenix metro

area. This needs to happen again. Also, the training was almost exclusively in Driver Education programs and supplemented the courses the schools already had in place. As more and more driver education programs are phased out, Jim and Joe have found that Health Curriculums are welcoming them and are using these as an effective tool for reaching students. Remember, we ae not teaching how to ride motorcycles. Rather, we are teaching how to avoid getting involved in accidents with motorcycles while driving. Jim and Joe have a finelytuned presentation (mostly Power Point) that they narrate so they are not just reading the screens to the kids. We intend to get this presentation recorded and placed online before the end of the year. We would then like the Chapter Safety Officers to become familiar with it and see if they can find opportunities near their chapters to start expanding the MAP program back to a state-wide initiative. This will take a little while, but the pieces are in place and it should be a relatively easy presentation to learn and present with the tools currently available.

Now for more mundane, but no less


important topics.

Chapter budgets are due October 1, so start looking at last year's budget and comparing it to the actual results (use the current process to develop yours until you are taught a new one).

State Officer positions expire at the end of the year so there will be State-Wide elections in November. I have not heard where this meeting will take place, but it is critical that as many members as possible participate to ensure the longevity of ABATE of AZ. If you have never held State Office, please consider it. The more brains we have working on a problem, the better the solution will be.



BUGS on your face

There are many great things about riding a motorcycle. The freedom of being out in the open, the wind in your hair, the smells of the countryside and the BUGS on your face. Well, maybe that last one isn't one of the great things, but it is certainly what the riders are talking about these days. The rains we got a few weeks ago were good for the lakes and vegetation but it has also been a catalyst for bug making. It's been a while since I have encountered this many while riding. Bugs have been such a big topic I decided to look up the term in the dictionary to see what Webster's had to say about them.

have been a poster child for one after that ride. I felt like a walking class insecta after that one. If I were still in 4th grade I could have just turned in my shirt, glasses and headlight, added a "Praying Mantis" and I would have gotten a "A" on my biology project.

What I find really interesting is all the different shapes, sizes, colors and tastes you can encounter. Some are sweet, some are sour and some have no taste at all. Some splash all over your face and some feel like a rock when they nail you in the cheek. Red and Yellow guts seem to have been the popular colors for Spring this year. It's also amazing how accurate these guys are. It's like there is some big control tower up there with "Bug Vader" barking out instructions to all the "suicide bugs". "Ok, we've got a guy daydreaming on a blue Titan doing 75 mph southbound on I-17, go for the left glasses lens. DIRECT HIT!! He'll be pulling over soon." I'm sure you can all relate to that.

The "Smart Bug". This is the one that can pinpoint the last available square centimeter on your glasses or windshield that is allowing you to see at all. Once hit by a "Smart Bug" you are forced to the side of the road for cleanup. You can always count on running into one of these on your trip.

The "Napalm Bug". This is the bug that hits and immediately explodes spreading a red and yellow substance over your face, clothing or glasses, sometimes causing a burning sensation on the skin and has a sour taste. If you clean this one off with your fingers in route, do not later touch your eyes or pick your teeth.

The "Cluster Bugs". This is a group of several thousand tiny bugs that fly together in a group. After riding through them you can find them stuck to your lip balm or held on by oily sunscreen. Requires a sharp fingernail to remove them as they smear easily if you try and wipe them off. Always keep mouth closed tightly while riding through "Cluster Bugs". of your riding buddies for up to 2 miles before giving up on it. This is AKA the "Ghost Bug". You know a bug went up your nose, it feels like it is still there, but you can rarely actually retrieve it. A Very frustrating bug that can actually take up to 10 miles to convince yourself that this bug is dead and not crawling around in your nose.

I'm not sure what all that tells me except that they were around before the first V-Twin and they are OBNOXIOUS PESTS. I did a ride up through Prescott, Jerome and Sedona a couple of weeks ago and had plenty of time to think while getting layered with all types of flying invertebrates. What is it about these guys that they feel it necessary to fly right in the middle of the road? They have millions of acres to fly, why does it have to be right at eye level in front of a motorcycle doing 70 mph. I'm not an entomologist, but I think I could So after about 20 hours and 740 miles of open road riding over the last 3 weeks I have had plenty of time to think. What could I relate these bugs to that would make the non-rider understand what this is like? There are so many ways that a bug can attack that I came up with this.

If bugs were bombs, here are what 7 of them would be:

"The "Bunker Bugster". This is the bug that hits you so hard in the cheek that it rattles your teeth, has a stinging sensation and feels like it is now firmly embedded and you will need tweezers to pull it out. You can almost imagine this one to have a sharp pointed beak and his feet are wigThe "Cruise Bug". This is classified as a SMART Bug that comes in from the side and can actually hit you in the ear while doing 70 mph. Not really sure how this one works. But it feels like a "Bunker Bugster" when it connects. If big enough it can actually make you change lanes.

The "Satellite Guided Bug". This is one of the smartest and most accurate bugs. This bug has been proven to be able to fly up your nose at speeds up to 90mph creating a very uncomfortable situation for the rider. This bug is very hard to retrieve and can make you look like a nose picker in front Hopefully the non-rider can now understand what we go through for the love of riding. As I have said before, being a motorcycle rider, it almost seems like we have an unfair advantage when it comes to building memories. Every day we fire up our motorcycles and head out on the open road, we are filling out another deposit slip for our memory bank of life. Bugs are certainly a part of that right now. And the more you ride, the more experiences you have to share with others. All that being said, I am ready to go back out there and do it again right now. And for the riders who will be out there too, the next time you get hit with a bug, make a quick mental note of which "Bug Bomb" you were hit with.

Pensacolians flock to Harley Davidson for spooky-themed discount tattoos on Friday the 13th

Sounds of buzzing needles replaced the roar of motorcycle engines Friday afternoon at Harley Davidson Pensacola, with dozens of people heading to the store to get special spooky-themed tattoos at a discount rate for Friday the 13th.

It's an unofficial tradition for tattoo studios to do specials on Friday the 13th, said Matt Herl, one of three tattoo artists who took up the back room of the Harley dealership on Friday. Herl and his fellow artists ran a "flash tattoo" sale where people could come in and pick from a predesigned set of ink for \$31, \$50, or \$100,

"It was always a traditional thing to do

back when tattoos used to be a macabre thing, more underground," he said. "And so now we do it to try to appeal to the dark side of people, and make it cheap. Back then they would do it for \$13."

Some of the pre-made designs people could choose from Friday included gravestones, potion bottles, ghosts, skeletons, spiders, broken hearts and bloody axes.

Stella Garrett, an emergency room registration technician, opted to get two \$31 tattoos on her arm - a voodoo doll, and a bust of Edgar Allan Poe. They joined a collection of two other Friday the 13th tattoos she had inked in previous years.

"I planned this, I had to crave my need for a tattoo without breaking the bank," Garrett said. "I guess I like that there's just not that much thought to it, it's

always just grab and go."

Lorenzo Rodriguez and his girlfriend Brittany Rollo came in to get tattoos, but opted not to go for matching ink. Rodriguez was getting a potion bottle on his arm, while Rollo got a cloud with an eye in the middle and a lightning bolt sticking through it on her wrist.

"If I didn't have bad luck, I wouldn't have any luck," she said when asked why she wanted to get a tattoo on Friday the 13th. "Matt (Herl) posted about this, and he's done a few tattoos for us, and it just seemed like a good idea."

Ryan McCool, another one of the tattoo artists, said the promotion was also a way for the artists to be able to continue working. Their Barrancas Avenue studio, Artistic Sol, burned down in July and the

crew is still rebuilding.

"We're a collective. When we work, we work together. When we catch fire, we catch fire together," he said.

The tattoos took an average of 10 to 20 minutes per person, and by 2 p.m. Friday, Herl said he was already on his way to shattering his previous record of 47 tattoos in one day.

The tattoo artists will continue to be at the Harley Davidson store at 6385 Pensacola Blvd. throughout the weekend. The store is having its bi-annual fall event, with motorcycle demonstrations for children, a bike show, food and market vendors.

France, Italy: Speed Cameras Charred, Junked

Vigilantes across France continue destroying speed cameras while an automated ticketing machine in Italy causes a massive freeway crash.

French speed camera charred


In Biancavilla, Italy, a speed camera caused a massive rear-end collision on the SS284 highway last week. Motorists

approaching the automated ticketing machine slammed on the brakes to avoid getting a citation in the mail, and this caused a chain of rear-enders that ended up creating a traffic jam in both directions of travel.

On Sunday, vigilantes in Cult, France, cut down the tamper-resistant Mesta Fusion 2 "turret" speed camera on the D67 and then set the device on fire. In Hennebont, the speed camera on the


D781 had its lenses covered with a thick coat of black paint. On Friday, a pair of speed cameras on the RN90 in Albertville were destroyed by fire. That day, the "turret" style speed camera on the RD44 in Goven was torched. Police have accused two individuals of being involved, but punishment could be light. Three Yellow Vest protestors accused of an earlier camera burning incident were given suspended sentences and a fine of 300 euros (US \$335) each last week by the Criminal

Court in Marseille. On Friday, the photo radar device on the D927 in Cormainville was blinded with brown paint. In Vire, the speed camera on the RD674 was blinded with black spraypaint on Wednesday. Around the same time, the photo radar unit on the RN145 in Saint-Maurice-la-Souterrain was set ablaze. The same fate befell the speed camera on the RN10 in Cloyes-les-Trois-Rivieres.

Motorcycle ride raises money for St. Jude

DYERSBURG, Tenn. — More than 200 motorcycles, nearly \$1 million and 450 miles.

Those are just some of the numbers involved in St. Jude Rides.

"Almost 400 people total, and to see it all come together, and to be here in Dyersburg, it is just overwhelmingly emotional," Jill Libert, development specialist at St. Jude Children's Research Hospital, said.

"One of the most well organized events that I've ever been a part of," Stann Wiebler, marketing manager at Walter Brothers Harley Davidson, said. "They do so much planning. The police do a phenomenal job of getting us here safely."

The trip started Thursday in Peoria, Illinois, where riders began a six-hour drive to Dyersburg. The motorcade arrived in Memphis on Friday, where they delivered a check worth around \$1 million to St. Jude.

Wiebler's father helped start the event 13 years ago, and Stann has done it the last six years. He says this event is one of his favorites.

"It's a huge event in our family. It's part of our business anymore. No decision goes in to our business these days without thinking about St. Jude and how it would affect it," Wiebler said.

"It's a very passionate group. They fund raise all year long with asking family and friends. They really are outstanding and selfless," Libert said.

Each rider raised at least \$1,000, with one couple even raising \$40,000.

"Kids are precious. Thank you to all the people who are here to do this," Kevin and Debbie Onnela said.

As they rode into the hospital parking lot, the patients and employees were there to welcome them.

"Patients, doctors, they all come out into the streets, and they have signs and balloons, screaming and yelling, a lot of tears flowing on these big, bad motorcyclists as they're coming in seeing the kids," Wiebler said.

"They do a lot for the kids. And I'm pretty impressed about that. They do a lot," rider Brian Bruen said.

Organizers with the group say they raise more money each year.


