The Current State of Arizona's Roads

• **Debris Management**: Loose gravel, fallen cargo, or other debris on the road must be cleared promptly to prevent accidents.

• **Signage and Visibility**: Poor or inadequate signage, particularly in areas with sharp curves or frequent construction, creates significant hazards for riders.

These challenges highlight the critical need for motorcyclists to have a voice in infrastructure policy decisions.



The Arizona Motorcycle Safety and Awareness Foundation (AMSAF) and Governor's Office of Highway Safety (GOHS) want to help. Our Financial Assistance Helmet program provides Individuals with \$125 from AMSAF and 25% off the Manufacturer's suggested retail price (MSRP) when you purchase a DOT-approved, full face or modular helmet at AMSAF approved locations roughout the state.



The Arizona Motorcycle Safety and Awareness Foundation **Financial Assistance Helmet Program**

How it works

- AMSAF Vouchers are valid towards the purchase of a \$200.00 or higher DOT Certified Full Face or Modular Street Helmet.
- · Vouchers are only valid to those dealers approved by AMSAF and listed on the AMSAF website.
- Vouchers are not valid for discounted, special order or discontinued heimets.
- Purchased heimet is non-returnable if warning tag is cut off. Heimets. may be returnable at the discretion of the dealer.
- . Voucher is valid for a \$125.00 credit toward qualified helmot due to grant received from the Governor's Office of Highway Safety.
- Dealer or store will give an additional 25% of helmet MSRP.
- \$50.00 tax doductible donation is required to AMSAF at time of application
- Voucher and promo code is only valid toward one (1) Helmel purchase.
- Dealer will credit individual up front at time of purchase and involce AMSAE

about responsible road sharing, helping to reduce crashes caused by driver negligence.

3. Infrastructure Advocacy

From lobbying for increased road maintenance funding to advocating for rider-specific safety measures like high-visibility signage, ABATE has been a driving force for infrastructure improvements.

4. Motorcycle Lane Filtering

ABATE successfully pushed for lane-filtering policies, protecting riders from rear-end collisions in traffic. Continued education on this law is crucial to ensure all road users understand its benefits.

5. Motorcycle Safety Fund Protection

Our advocacy has safeguarded Arizona's Motorcycle Safety Fund, ensuring resources remain available for rider training and road safety programs.

Emerging Challenges and Opportunities



MRF News: Friday From DC Coming In 2025

December 20, 2024...

In September, at the 2024 Motorcycle Riders Foundation's (MRF) 40th Annual Meeting of the

Minds Conference, held in St. Louis, Missouri, a legislative strategy session was hosted by the MRF's Legislative Committee. The purpose of the session was to establish and prioritize the MRF's 2025 Federal Legislative Agenda.

Legislative issues fall into one of three priority categories: high, medium and monitor. This list remains fluid and can be adapted depending on the issue and political environment.

Below is a brief description of just the top 11 issues on the MRF's 2025 agenda listed as "High Priority." The January 2025 issue of the American Bikers Journal will have more detail on each of these high-priority issues as well as the full list of an additional 13 priorities that fall in the "Medium" or "Monitor" classification.

The 2025 Motorcycle Riders Foundation Legislative Priorities List:

HIGH PRIORITY OBJECTIVES:

Autonomous Vehicles: Advocate and monitor any legislation or regulations related to motorcycles concerning connected and autonomous vehicles.

Crash Avoidance: Continue to promote the theme of crash avoidance versus safer crashing, urging the National Highway Traffic Safety Administration (NHTSA) and the U.S. Department of Transportation (DOT) to focus on crash prevention and support rider education by providing funding and other resources.

Data Recording: Pursue legislative language that any collected or available vehicle data is the property of the consumer and the consumer has the choice of whether to opt-in to having their data communicated to interested parties.

Definition of a Motorcycle: Educate policymakers and advocate for change to the current definition that better reflects the current two and three-wheel motorcycle landscape.

Emission Regulations: Engage the Environmental Protection Agency (EPA) & Congress on any activity related to motorcycle emission regulations.

Helmet Laws: Oppose any mandatory federal helmet, apparel or conspicuity requirements.

Internal Combustion Engines: Work to ensure the survival of internal combustion engines.

Profiling: Sustain lobbying efforts for the passage of resolutions or legislation that promote awareness and prohibition of motorcyclist profiling.

Renewable Fuels: Advocate for targeted changes to the Renewable Fuel Standard (RFS).

Right to Repair/Modify: Protect and advocate for "Right to Repair" provisions that allow consumers to repair and modify their motorcycles.

Vulnerable Roadway User Terminology: Monitor and ensure that motorcycles and motorcyclists are a specific and unique category or classification.


Safety Report



Traffic Signal Giving You the Silent Treatment? Let's Fix It!

Motorcycles don't always trigger traffic signals due to insufficient weight or magnetic presence. But don't worry, we've got some tips and a solution for you:

Try This First:

1. Align your tires over the edges of the sensor loops (look for visible cuts in the pavement).

2. Flash your high beams—some signals use optical sensors that might respond!

Still No Luck?

If a signal won't recognize your motorcycle, let me know! Send an email to lobbyist@abateofaz.org with:

The signal's location

Your direction of travel

What lane you were in

I'll contact the local streets department and get it fixed ASAP.

Pro Tip: Always watch out for red-light runners and stay alert at intersections. Safety first!

Let's make the roads safer and more motorcycle-friendly, one signal at a time.

An additional tip suggested is to flip your kickstand down. Sometimes it's just enough additional metal within the magnetic field of the sensor to work. Just don't forget to flip it back up when you depart!



Masterlink Motorcycle Awareness Program {MAP}

The 2024 Motorcycle Awareness Program finished up in November. We presented the program to approximately 900 students this year. Thanks to East Valley Chapter members for their assistance and participation!

ABATE of Arizona is working on its Motorcycle Awareness Program's strategic plan for 2025. Your input and participation are requested to support presenting ABATE's program to the high schools in the following areas: Marana HS, Tucson HS, Flagstaff, Show Low area, Florence area, East Valley, Deer Valley, West Valley, Prescott area, Kingman area, and Casa Grande area. The goal is to have 80 or more students per school take the class within the calendar year.

The MAP needs support of motorcycle riders to assist with presenting the program. This help can be either by becoming a certified instructor or by helping with the outdoor demonstrations. The program also needs riders to help obtain contact with area high schools to arrange presentation opportunities. Your support to help arrange these presentation opportunities would be of great assistance.

There are too many accidents caused by motorists who failed to yield the right of way. More than ever, ABATE's program needs the support of all state members to help present it to their area schools or organizations. Imagine the possibilities if we can educate all car drivers to be aware of motorcycles!

For those who might be interested in becoming a MAP instructor, please read on.

The Motorcycle Awareness Program (M.A.P.) is an educational program aimed at the target audience of high school students in drivers education classes. There has been a small group of instructors who have volunteered to present the M.A.P. to students throughout the state, but we need more instructors.

Remember that ABATE's E stands for EDUCATION. Our purpose is to spread the word about safe motorcycling and promote a positive image of motorcyclists. What better way than to speak to the future drivers of our state? The students, hopefully, will not only be better equipped car and truck drivers but will also be more aware and watch out for us.

To become an instructor you must:

1. Be available during the day: The presentations in driver's education classes last about an hour during the school day. There may as many as 5 classes in one day.

2. Be willing to stand up in front of a group of about 30 high school students and speak. That sounds easier than it can be. You need to be able to gently maintain control of the group.

3. Know the material being presented. There is an outline for all presenters to follow so there is uniformity in the material presented.

4. Commit to teaching at least two classes per school year. We hope to have at least one volunteer instructor in each ABATE chapter. That person will attend an instructor class (about 4 hours), attend a M.A.P. with an experienced instructor, and teach a class with an experienced instructor in attendance. When the new instructor is comfortable and the experienced instructor assesses him/ her to be ready, the new instructor may begin teaching alone. The mentor program assures that everyone is teaching the same material and everyone has support.

5. Provide record of teaching to M.A.P. Coordinator on a consistent basis.

This is your opportunity to get the word out to new drivers about the importance of sharing the road with motorcyclists. This is your opportunity to support the mission and vision of ABATE in your community.


Vice-President's Report

LANE FILTERING IS LEGAL		
ARIZONA REVISED STATUTES 28-903 F The operator of a two-wheeled motorcycle may overtake and pass another vehicle that is stopped in the same direction of travel and in the same lane as the operator and may operate the motorcycle between lanes of traffic if the movement may be made safely and if the operator does both of the following:		
 Operates the motorcycle on a street that both: (a) Is divided into at least two adjacent traffic lanes in the same direction of travel. 		
(b) Has a speed limit that does not exceed forty-five miles per		
hour. 2. Travels at a speed that does not exceed fifteen miles per hour.		



December 19, 2024 - Washington DC ... Wednesday morning, the Environmental Protection Agency (EPA) granted California a requested waiver to implement new emissions standards on some vehicles. With this decision, California has the authority to activate its plan and phase out the sale of gas-powered cars and light-duty trucks in the state by 2035.

This waiver had been awaiting approval since May 2023 but was signed off on just a month before President Biden leaves office. A Trump spokesperson said earlier this week that the president-elect has "a mandate to implement the promises he made on the campaign trail, including stopping attacks on gas-powered cars."

The incoming Trump Administration will have the power to revoke this new waiver. However, the process of doing so can be lengthy and ultimately could be overturned in future years by a different presidential administration.

Thankfully for motorcyclists, the California Air Resources Board (CARB) withdrew a similar plan that would require half of new motorcycles sold in the state to be electric in the next ten years. That motorcycle proposal would also have required a waiver. However, because of the timing of the California motorcycle plan, any waiver would have been consid-

ered by a Trump-lead EPA.

A former CARB board member said of the decision to withdraw the motorcycle rules, "With the EPA waiver virtually guaranteed to be denied, pushing forward would have risked wasting political capital and alienating key stakeholders."

The changing political landscape in Washington, D.C., is impacting a variety of issues that we as bikers care about. The Motorcycle Riders Foundation remains engaged and fighting for the policies that affect you as a motorcyclist.
