- 2. Treasurer Tara Rudometkin

- 3. Legislative Director's Report Michael Infanzon
 - HB2115 Motorcycle Safety Fund passed COW unanimously. Only 1 nay vote – funding extended 4 more years.
 - The proposed California Emissions bill was killed.
 - Looks like the Legislative session will be over in June.
 - Deb Butitta Motorcycle Advisory Council in Congress.
 - All Roadways Improvement Planning & Safety passed rules and to go to COW.
 - Autonomous Vehicle bill passed.
- 4. Bylaws/P&P's Committee Deena Grady Lyn and I are working on them. We are going to make notes for the Bylaws as they may only be changed every 5 years and they were last changed in 2017. As the Bylaws Committee is required to be a 3-member committee, Deborah Butitta was going to ask Suni Summers of Yavapai Chapter if she will be the third committee member.

- 4.
