# Legislative Director -

Lane filtering passed 8-1; Jeremy from Tucson came up to testify on it's behalf. SB1276 – two-wheeled motorcycle operation – MRF was involved for Call to Action via text message and/or phone call. Going to Rules Committee Monday then on to and Caucus, etc.

Need to have as much participation as possible from the "Call to Actions'  $\sim$  26 have signed in support of this bill with the system.

We have the votes in the Senate & House to pass  $\sim$  3 groups are against.

17 Bills are being monitored closely by LD.

Need to use the SB Bill to gain members.

Non-ABATE fundraisers donated monies to Legislators who support motorcyclists after their session is over.

Day at the Dome ~ April  $3^{rd}$  Sunday okay with everyone? Responded in agreement; will resubmit request for this day.

Safety – Absent, no report

**Merchandise** – Working with a company on getting hats & hoodies; working with an online company about coozies & cups; will send that info to State Officers. Online has a minimum order qty for discount – can almost triple the cost when we sell. Need to utilize our online store; be sure to include shipping costs for items.



# PAC -

Elections: 435 Hse of Reps & Congress 1/3 of Senate, & State up for re-election in Nov; once that information is available will share that information; should have that at March's meeting. Nat'l Roadway Safety: estimated 38,680 fatalities in the nation; 9% were motorcycles; Gov't allocated 14B for this campaign.

MRF: we are still trying to get 366 (anti-profiling) co-sponsors; referred to sub-house committee. Andy Biggs hasn't responded ~ LD advised to contact Andy's counterparts.

Communicate with Jeremy quite often; will be reaching out to Chapt PAC Officers after they're trained.

Education: Make sure at Chapt level & on Social Media: need to clarify lane splitting vs. lane filtering; share on Social Media – look at all Chapters pages.

Tucson: Director of Safety for PD's position has been dissolved & no Transportation Director now; new one will be announced in March.

There's a .5 cent tax increase on RTA system proposal

Redistricting is complete ~ going to legal process now.
