Our status as a nonprofit has been suspended, we are 501c4 not a 501c3, so we have to pay sales taxes. Going forward we will have to write off the sales tax paid & sales tax received so it will be a wash on our taxes. We have to keep records of all sales tax made going forward. Thankfully Monica has all records going back 4 yrs. from Dawn. State has lost their State PAC officer, State Sargeant of Arms & Merchandise. If anyone is interested at least 2 are needed to step up, as 1 has been filled& Anissa is now the State PAC officer.
